



Rally Pushes to Reopen St. Mary's Businesses, Change

Laws

Dozens of people supporting the Reopen St. Mary's movement, which seeks to have the state relent from its pandemic-induced restrictions on bars, restaurants and churches. marched along Route 235 May 23 to boost support for their cause.

But more than just pressing Gov. Larry Hogan to ease his restrictions on businesses being allowed to open up to full capacity, the movement, which part of a statewide effort, is seeking to amend the law that gives the governor his emergency powers.

"We want to see businesses and churches... back to 100 percent" before the pandemic, said Deb Rey, a former state delegate for St. Mary's and a member of the reopen

She and others dispute the legitimacy of Hogan's many executive orders during the pandemic and want to change the law, particularly Title 14 of the state's constitution that provides for emergency powers.

Particularly they want to change how many times the governor can extend executive orders without the consent of the state legislature and they also want to amend his powers under the law to force people to be vaccinated.

Rey said business owners she has spoken with are worried by the powers of the state under the pandemic, including having their licenses revoked for trying to keep their businesses operating.

"If they could meet all the health requirements before the pandemic, why can't we trust them to do it afterwards?" Rey asked. "Why can't they institute the same kinds of practices as stores like Wal-Mart, which have been open the whole time?'

Del. Matt Morgan, a former colleague of Rey's, announced May 27 that the House Republican Caucus had written to Hogan pressing him to relax restrictions on businesses such as restaurants, bars and gyms, which are largely still closed.

'While we are not requesting an immediate return to normalcy, we do believe we can and should open many more businesses and activities at a faster pace," Morgan wrote in a public statement. "We believe that if Lowe's and Walmart can be open, restaurants and gyms can responsibly re-open at least at 50 percent capacity.

We encourage the state to grant waivers to restaurants to allow them to use areas outside of their facilities for outside seating. Further, we believe outdoor ceremonies like graduations and drive-in movie theaters can be responsibly re-opened."

Rey said the key was to amend the fundamental emergency powers of the state.

"In the end we need to change the law," Rey

Hogan Eases COVID-19 Restricitons

Noting significant declines in CO-VID-19 infection rates throughout the state, Gov. Larry Hogan announced Wednesday that starting May 29 restaurants could reopen to outdoor dining and other outdoor sporting activities and social organizations can also resume with some restrictions still in place.

He even noted that Prince George's and Montgomery counties had been able to cut the positive test rates for CO-VID-19 by more than 50 percent; also, the death rate has dropped by about 50

"We've been encouraged by all the Stage No. 1 openings across the state," Hogan said.

Youth camps can resume, the governor said, as well as youth sports as long as contact can be lowered, and group sizes limited.

Also, no out-of-state campers will be allowed and campers and staff will have to have daily symptom checks.

Outdoor swimming pools can also be reopened, Hogan said, at 25 percent of capacity and with warnings clearly posted that anyone who is ill should not use the facility.

Drive-in movie theatres can also re-

open, the governor said.

For restaurants providing outdoor seating, there can be no more than six people seated per table and menus and tables and seats must be sanitized before reuse.

Hogan noted that many communities around Maryland had closed some streets to allow restaurants to expand their outdoor seating and encouraged counties to find "creative ways" to help restaurants.

"It can help many struggling restaurants to survive this crisis," Hogan said.

If COVID-19 metrics continue to trend downward, Hogan said, Phase No. 2 of the state's recovery plan could begin as early as next week.

Under the second phase of the plan more so-called non-essential businesses would be allowed to open and restrictions on restaurants would be further relaxed

Hogan warned that COVID-19 still presented a deadly threat, but it was one Marylanders could defeat with patience and caution.

"We must all continue to be more vigilant," Hogan said. "COVID 19 is still very much a deadly threat... [but] we truly are on the road to recovery."

COVID-19 Cases at Veterans' Home Continue to Climb

The Charlotte Hall Veterans Home continues to have a high concentration of COVID-19 cases in St. Mary's County with 172 confirmed; 122 residents either have or have had the disease according to the St. Mary's County Health Department.

The remainder, 50 cases, were among staff at the facility according to the latest figures.

The two other assisted living facilities in St. Mary's County, Chesapeake Shores and St. Mary's Nursing Center have seen no increase in their COVID -19 cases.

Chesapeake Shores reports eight cases, two among residents and six among staff, while St. Mary's Nursing has reported no COVID-19 cases since the outbreak three months ago.

As of Tuesday, there were a confirmed 396 coronavirus cases throughout the county and 15 deaths.

The facility's size contributes in part to the spread of the disease, according to the county's health officer Dr. Meena Brewster.

"In a facility like Charlotte Hall Veterans Home, which is several times larger than our other two long term care facilities, the risk of the virus being introduced into the facility by any one person is greater because you have so many more staff who come and go and so many more residents that may need outside medical attention," Brewster said. "This, combined with the asymptomatic spread of a highly contagious virus, presents an extraordinary challenge for infection control."

All the long-term care facilities here have worked hard to combat the virus, she said.

"All of our long term care facilities in this county were aggressive early on in the course of this pandemic, implementing measures to minimize the risk of infection, including those required by state orders," Brewster said. "But you can't completely close the doors to risk. You are taking care of a very vulnerable population that has medical issues - they are inevitably going to need outside medical services that require them to leave the facility and obtain those services, and then come back to their facility home.

"Your staff don't live at the facility - they go back to their families and communities between shifts."

New Section of FDR to Open Soon

After several years of delays and construction setbacks the section of FDR Boulevard that intersects with Chancellors Run Road and runs through the Hickory Hills community is set to open next month.

Now called Amber Drive, the section of FDR Boulevard will get its name changed June 9, which will also be the date the roadway will be opened to traffic.

"It's basically done," said John Deatrick, chief of county public works and transportation. "We've got a couple of road signs to put in."

Deatrick said the department had the construction contractor take "fairly drastic action" in March when rains began to fall, stalling the project.

The ground around and underneath the roadway wasn't drying fast enough, Deatrick said, so they ordered more drainage placed at the site to remedy the problem

"If we hadn't done that, we would've been late, very late," Deatrick told The County Times. "We finally got ahead of the weather.

"We're relieved and happy to report

The extra section of FDR Boulevard will allow extra access to neighborhoods for residents as well as another option for avoiding traffic on Route 235, which it parallels.

The new section of road will also allow easy access to shopping along that section of Route 235 as well, Deatrick said.

"It definitely will help," Deatrick said. According to county government, the extension and connection of the FDR Boulevard roadway will allow traffic to flow between MD 4 - St. Andrews Church Road and MD 237 - Chancellors Run Road.

Because of this extension and connection, additional traffic volume will occur within the Laurel Glen, Beverly Hills and Hickory Hills communities. The county warned that pedestrians and cyclists should be aware of the increased vehicular traffic and use only designated crosswalk locations for crossing FDR Boulevard.

COVID-19 Survivor Tells Her Story

Seeing the statistics for COVID-19 cases can be worrisome, but actually having the disease is another story. For former teacher and current nurse Michele Spaulding of Huntingtown, contracting the coronavirus meant lots of questions because she had the first documented case in Calvert County.

What initially seemed like a common cold quickly escalated into a more serious illness. On March 17, Spaulding woke up and didn't feel well. She explained, "I woke up that morning with a runny nose and bit of a headache... And I said, 'Wow, I'm just feeling a little under the weather. I wonder if I ended up getting a cold or something.' And I honestly did not even really connect the dots at all at that time."

Within hours, her body began to ache, her eyes began to burn, and her temperature began to rise. She realized her symptoms indicated something worse than a cold. That's when Spaulding called her doctor at Johns Hopkins Community Physicians and was told to come in for testing.

Since she had an early case of the coronavirus in the U.S., the testing process for Spaulding was complicated. There were specific instructions about where she would get the test, which she didn't find out until she was on her way to the hospital. "It felt like you were on a Mission Impossible situation," she said jokingly.

On March 18, she received a nasal swab test at Johns Hopkins for COVID-19, as well as testing for Influenza A. By the morning of March 19, she had confirmation from her doctor that she was positive for the coronavirus. Soon after receiving that call, Spaulding was also contacted by the Calvert County Health Department.

She mentioned that it is possible she caught COVID-19 from her 22-year-old daughter, Catie. Spaulding explained, "[Catie] teaches in Connecticut in Greenwich...which is literally right outside of New Rochelle [NY], like five miles' distance between where the epicenter was for COVID in the U.S."

In February, Catie had been sick with, what seemed to be, a sinus infection. When she arrived at home during the school's spring break, nothing seemed out of the ordinary. "Of course, I give her a hug. You know, 'Welcome home," Spaulding said.

However, after experimenting at home with various seasonings, it was determined that Catie had completely lost her sense of smell. And her antibody test was later confirmed to be positive, meaning she had had the coronavirus.

Of course, Spaulding realized it's impossible to determine that she definitely contracted

the virus from her daughter. "We can make the assumption," Spaulding noted, "presuming where I got it from. But, at the same time, who knows? You know, you go to the grocery store, you pump your gas in your car, all of those things. There's a chance you could pick it up."

Though it's uncertain exactly how she contracted COVID-19, Spaulding undoubtedly faced several difficult weeks. What made her illness even harder for her and her family was that they lost friends to the coronavirus, including healthcare professionals that Spaulding knew and the brother of Catie's close friend.

Although Spaulding's illness did progress, she noted, "I was very fortunate that I did not have to be hospitalized." With time and Tylenol, she made a solid recovery, though she hasn't recovered fully from the headaches and exhaustion.

Thankfully, she has not let the continued side effects stop her from giving back to others. "Around the 31st of March, I made it past that second week, which was the scary part. And I started doing a lot of research on the convalescent plasma, trying to find out how can we donate...," Spaulding stated.

An individual who has recovered from CO-VID-19 can donate convalescent plasma to help save the lives of others who have the virus because the donating individual has developed antibodies to this virus.

Due to earlier limitations on convalescent plasma donation, Spaulding could not donate right away. But the restrictions were later updated, so she donated convalescent plasma on April 28 at Anne Arundel Medical Center. She plans to do it again and advocates that any previous COVID-19 patients donate convalescent plasma also.

In addition to convalescent plasma donation, she has helped fellow medical professionals gain new perspective on the coronavirus. She said, "Many friends who are either nurse practitioners or physicians...ended up contacting me because they didn't feel like they were getting a lot of resources of how to talk to patients because it's such a novel virus, so I was a sounding board for them."

Although she hasn't worked in an actual hospital recently, Spaulding has played an important role in the medical field through triaging. At home, she has answered questions over the phone for volunteer organization Maryland Responds. She stated, "It's been hard not being there firsthand, but at the same time, I'm really fortunate that I've been able to do what I'm doing..."

As for tips to prevent COVID-19, Spaulding emphasized the importance of staying home and avoiding cross-contamination. She did, however, describe glove-wearing as "a very false sense of security."

Though it's a huge transition for Americans, mask-wearing is important, said Spaulding. Also important is the way that individuals put on and take off their gloves and masks. She added, "Wash your hands, wash your hands, wash your hands much more than you think you need to."

On a mental and emotional level, she believes in the value of adaptability and positivity. "I think this is a great opportunity for people to look at ways that they can help someone else," she advised. She noted that people should look out for others, not just themselves.

Blue Crab Population Deemed Healthy

Winter Dredge Survey Finds Normal Fluctuation

The Maryland Department of Natural Resources announced the results of the 2020 Blue Crab Winter Dredge Survey, a cooperative effort with the Virginia Institute of Marine Science, which estimates the number of blue crabs in the Chesapeake Bay annually.

The 2020 results showed that the Chesapeake Bay blue crab population maintains a healthy number of spawning-age female crabs. Maryland, Virginia, and the Potomac River Fisheries Commission strive to conserve more than 70 million adult female crabs annually to ensure enough young crabs can be produced to sustain the population, which has now been achieved for the sixth consecutive year. This year's survey estimates 141 million adult female crabs were conserved, which is above the long-term average of 126 million.

Additionally, the results showed there were 79 million adult male crabs, just above the long-term average of 77 million and similar to the estimate from 2019. The total abundance of blue crab in the Chesapeake Bay in 2020 was 405 million crabs, a near-average abundance for the 30 years of survey results.

The number of juvenile crabs

declined in 2020 to 185 million, from last year's total of 323 million. Juvenile abundance is largely driven by environmental factors, such as currents, temperature, and winds, therefore year-to-year variability is expected.

"While there are some expected fluctuations, our collective management efforts continue to enable the population to stay resilient and sustainable," Maryland Department of Natural Resources Secretary Jeannie Haddaway-Riccio said. "Maryland blue crabs remain an iconic part of our heritage and our environment."

Although juvenile abundance this year is below the long-term average of 254 million, it remains an improvement from the 2018 recruitment and well above the low of 105 million reported in 1992.

"The results indicate the population remains in a healthy, sustainable condition," Maryland Natural Resources Fisheries Monitoring and Assessment Director Michael Luisi said. "Continued diligence to our management plan for blue crabs will ensure protection of the resource and sustainability of the fishery."

The Chesapeake Bay Stock Assessment Committee will review the survey results and release its full analysis in its 2020 Blue Crab Advisory Report this summer.

The Department will begin discussions with the Blue Crab Industry Advisory Committee to provide guidance to the Department concerning the course of action for 2020 that promotes the health of the Chesapeake Bay blue crab population and its fisheries.

The Winter Dredge Survey has been conducted cooperatively by the Maryland Department of Natural Resources and the Virginia Institute of Marine Science since 1990 and the results are reviewed annually in an effort to have consistent management efforts across the jurisdictions. Throughout the survey, biologists use dredge equipment to capture, measure, record, and release blue crabs at 1,500 sites throughout the Chesapeake Bay from December through March.

School Board Reallocates COVID Savings

Two Concerned Members Vote Against By Dick Myers is anticipated in federal stimulus money

On a 3-2 vote, the Calvert County Board of Education has transferred transportation savings due to COVID-19 to other nonbudgeted items.

With \$320,720 in savings because buses aren't running, the proposal presented at the May 21 school board meeting was to use it to pay off the final two years of a GPS lease and to replace two vehicles for administrators.

School board member Dawn Balinski was one of the two opposing votes. She said, "I think we as a board need to decide how we are going to utilize these savings. If things were not budgeted theoretically that means that they weren't a showstopper for our operations. But, if we should be creating a rainy-day fund, that's my question."

School Superintendent Dr. Daniel Curry said he and Chief Financial Officer Edith Hutchins had been talking about how to build up a reserve for anticipated costs related to the Kirwan Commission reforms. Bur he also anticipates significant costs due to COvID.

"I can tell you also we've got some immediate expenses that we're looking at for the near future, for August and what will school look like next year. We can spend some money pretty fast if school was not going to look like it has in the past." he said.

Curry said Deputy Superintendent for Instruction Diane Workman had been developing a list of requests. He said that list is now at \$2 million and only about \$1 million

coming to the county through the state. "We won't have any difficulty spending as we get closer to knowing what the next school year will look like."

Balinski replied, "It's those kinds of unknowns that gives me pause to do some purchases that we didn't even think were important enough to put in next year's budget."

School board Vice President Inez Claggett questioned the decision to purchase new vehicles. Hutchins said the vehicles had some age on them. And Curry added, "These are the folks who traveled the roads checking for the condition of the roads in bad weather.'

Hutchins observed there were potential budget savings available for other COVID-19 costs. She said, "Right now we have a committee that has been reviewing the need to purchase personal protective equipment. We currently have an estimated cost of \$300,600 for that. We have enough savings across various categories to be able to pay for that expense by using 2020 funds."

In the end Balinski voted against the motion as did Claggett. The motion also included transfer of special education savings to cover the costs of laptops for online learning. Balinski said she favored the special education transfer but had to vote against the entire motion because it included the COVID transportation transfer.

Planners Like Burgers and Donuts

New Chair and Vice Chair Elected

After having several meetings postponed because of the coronavirus pandemic, the Calvert County Planning Commission swung back into action on May 20 by approving two fast-food restaurant redevelopment projects. The planners approved the demolition of the existing McDonald's in Prince Frederick and replacement with a brand-new building, and renovation of the former Starbucks in Dunkirk's Gateway Plaza to be repurposed as a Dunkin' Donuts.

Both approvals were quickly given and were unanimous

According to a memo on the McDonald's project to the planners by Acting Planning Commission Administrator Rachel O'Shea, "the project proposes to demolish the existing 4,555-squarefoot McDonalds building and replace with a 5,280 square-foot building with a two-lane drive through along with site improvements to the parking lot, sidewalk, utilities, stormwater management and landscaping."

As to the Dunkin' Donuts, O'Shea wrote, "The project proposes to redevelop the site by partially replacing the sidewalk adjacent to the building and 12 parking spaces with a drive-thru and

stormwater management facility. The existing building is 9,102 square feet; the end unit that will be converted to the Dunkin Donuts is 1,620 square feet."

New Chair, Vice Chair Elected

Chairman Greg Kernan was ineligible for reelection because he had served two terms. So, he nominated his vice chairman, Steve Jones as his replacement and the vote for Jones was unanimous. Maria Buehler was elected vice chair.

Jones first joined the planning commission as an alternate in November of 2016 to help fill the hole left by the Calvert County Board of County Commissioners suspension of the planning commission chair and vice chair and later firing of the chairman, Maurice Lusby. Jones was later elevated by the commissioners to full membership.

Jones originally retired from the Calvert County Sheriff's Office as a captain and later rejoined and is now a major. He heads up the security detail at Dominion Cove Point LNG



Deputies Break Up Stunt Drivers in Charlotte Hall

Law officers from both St. Mary's and Charles counties brought a halt to and dispersed a large group of illegal racers performing vehicle stunts at the Charlotte Hall Park and Ride facility along Golden Beach Road the night of May 22, The County Times has learned.

As many as 400 vehicles, most originally coming from Oxon Hill in Prince George's County, St. Mary's sheriff's office representatives said, crowded into the park and ride after going to several sites in Charles County and performing many of the same illegal races and vehicle stunts.

Cpl. Julie Yingling, spokesperson for the St. Mary's sheriff's office said internet-based groups of car enthusiasts decided to meet at the park and ride for unknown reasons but acknowledged the attraction of the site for drivers.

"It's a large open area," Yingling said.

When deputies arrived on scene and observed numerous vehicles along Golden Beach Road and in both the Park and Ride lot as well as the Social

Security Administration parking lot, numerous people fled the area on foot and in vehicles, according to a sheriff's office statment.

Deputies conducted several traffic stops for violations and 13 citations were issued. One vehicle was towed from the scene as a result. It took approximately 30-45 minutes for deputies to disperse the vehicles from the area.

Sheriff's deputies are continuing to watch video footage taken of the incident for potential traffic and criminal charges against vehicle operators, a statement from the sheriff's office read.

Yingling said the group had started their activities earlier that night at Regency Stadium in Charles County and other parking lots of shopping centers there as well; this is what brought Charles deputies down to St. Mary's in pursuit of some of these drivers.

Historic Events For Class of 2020

March 12, 2020

Last day of schools; they remained closed for the rest of the school year.

March 23, 2020

Only essential businesses could be open, so most clothing stores, gift shops, nail salons, beauty shops closed. Restaurants open for only take out. Most government offices, court houses, etc closed or working from home.

March 30,2020

The stay at home order began, citizens could only leave home for essential things like groceries, to pick up meals or for work if they had an essential job. No gatherings of 10 people or more allowed. All outdoor events were cancelled or prohibited

April 18, 2020

Face masks were required inside any business in the State of Maryland that was still open, customers had to stay at least six feet away from others.

May 15, 2020

Gov. Larry Hogan initiates first phase of his statewide recovery plan and lifts his stay at home order. Retail establishments and churches could reopen with social distancing in place and masking as long as they only operated at 50 percent of customer capacity. Restaurants and bars had to remain closed to sit-down customers.

Town Remembers Fallen Survey Open on Prince Local Hero

Chesapeake Beach Holds Virtual Ceremony

The 9th Annual Stars and Stripes Festival in Chesapeake Beach this Memorial Day will be one to be especially remembered. For one thing, like much of what is going down these days, it was held virtually. But it also was special for remembering a fallen local hero, SSG Christopher W Swanson

During the ceremony Mayor Patrick "Irish" Mahoney unveiled SSG Christopher W. Swanson Way at the Chesapeake Beach Veterans Memorial Park in honor of Swanson.

According to the ceremony notes: "SSG Christopher W. Swanson, a brother, uncle, son, and a lifelong resident of the State of Maryland, grew up in Southern Maryland and the Twin Beaches. Chris was tragically killed in action while serving his third tour in Iraq.

Swanson's father Gary spoke during the ceremony with his wife Kelly, their son Ken and Gary's brother Glen standing beside him.

Gary Swanson said, "We're so grateful for the town of Chesapeake Beach and the passion they have for service members." He noted the town's commitment to honoring the true meaning of Memorial Day.

Swanson said, "Chris was a lifelong resident here in Southern Maryland, south Anne Arundel County and around the beaches. He loved his slice of paradise here on the Bay and we are so grateful once again for everything our community continues to do. Remember our fallen soldiers, those who are serving, and although this is going to be a little different as far as the festivities going on here in the beach, we can always take pause to remember those sacrifices for the freedoms that we enjoy. Freedom does have a price, and we're so grateful for those in our community that have served and continue to serve and do good with their last measure of life for this great country.'

According to the program, "On July 22, 2006, Army Staff Sergeant Christopher Swanson was killed by sniper fire while leading his squad during a combat patrol in Ramadi, Iraq. He believed in his mission and loved leading his men. Just 10 days before Chris was killed by a sniper, he was injured by an IED and required 20 staples to his leg. Chris could have used this injury to go on a medical R&R but chose to stay and be there for his men. This shows

the character of all that is good with those who put others above self. Upon returning home on leave after deployments the first thing SSG Christopher Swanson would do is head to Walter Reed to check on his injured soldiers. Chris, who was born and raised in Marvland, devoted his whole life to service. As a kid, Chris began helping others on mission trips across the U.S. as well as other volunteer activities through his church. After graduating from high school, Chris was offered a prestigious appointment to US Military Academy at West Point, but instead he turned this appointment down because he wanted to serve his country immediately. Chris enlisted in the Army and was assigned to the 82nd Airborne Division where he was on the initial assault to Iraq. On his third deployment to Iraq, as he was serving our country, Chris was killed in action.'

The virtual ceremony included musical performances by groups who normally would have appeared live at the weekend town festival. It also featured personal remembrances from town council members and others including Maryland Veterans Secretary George Owings of Calvert County.

Owings said Memorial Day is more than sales, cookouts and going to the beach. He said Memorial Day was about remembering those "who raised their right hand, took an oath, went into battle and never returned.

The honors for SSG Swanson concluded with the following message: "For those that fight for it, freedom has a taste that those protected will never know. The high price of freedom is a cost paid by a brave few'

The Calvert County Department of Planning and Zoning is continuing to solicit comments on a second survey. Deadline for submitting comments is 11:55 p.m. on

The survey includes demographic questions, including ZIP Code and age range. The number of responses from the Prince Frederick ZIP Code 20678 was 20.5 percent, and combination of the two age ranges, 50-59 and 60 and over equals 71.4 percent of participants.

Based on the first survey, whose results were revealed at the last public meetings on Jan. 30 and March 2 and responses from the second survey, staff has recommended and the planning commission at their May 20 meeting concurred to narrow the focus for future public sessions. As of April 23, according to Long-Range Planner Jenny Plummer-Welker, 214 additional survey participants had been heard from.


The narrowed focus areas accepted by the planners are "land use and transportation." Those two broad categories came out one and two in the first survey results followed by economic vitality, public safety, and environmental/natural resources.

The March 2 meeting took place at College of Southern Maryland, but that venue is closed at least until Sept. 1. Plummer-Welker in her memo to the planning commission, said as the process proceeds, "staff continue to research virtual meetings and other community engagement methods."

Wilkes Says She Will Represent the Working at Hollywood **Class of the 5th District**

Charles County resident Mckayla Wilkes is running to unseat longreigning U.S. Rep Steny Hoyer as the Democratic candidate for the 5th Congressional District seat, saying the incumbent does not represent the working-class residents there.

"Regular people deserve to be represented by regular people," Wilkes said. "We need a change."

Wilkes supports universal healthcare, criminal justice reform and federal funding for affordable housing as well as Section 8 housing.

She also supports the Green New Deal and is against the use of fossil fuels and wants to see the country move completely to renewable energy resources

Hoyer also has touted his support for universal health care coverage he was a key vote in the passage of the Affordable Care Act – but Wilkes said Hoyer has not done enough to ensure people can get true affordable healthcare.

We already have access to healthcare, the question is affordability,' Wilkes said. "I tried to purchase healthcare from the exchange, and I can tell you it's not affordable.

She said at one time she had to take a drug for deep vein thrombosis that threatened to bankrupt her and became unavailable when she didn't have health insurance

'It cost \$30,000 for a 30-day supply," she said. "We don't have a healthcare system, we have a health insurance system.

On housing, Wilkes wants to invest federal funds in counties and municipalities to build affordable housing stock for working class residents and families, she said, and also wants to use federal money to fully fund the Section 8 program nationwide.

'Section 8 has a years-long wait time," Wilkes said of the housing available for low-income families paid for in part by federal money. "It would only cost \$40 billion to fully fund Sec-





tion 8 housing.

"It could eliminate homelessness."

Wilkes also supports limiting military intervention abroad and eliminating what she calls wasteful defense spending; the minimum amount she wants to cut from defense spending is \$200 billion.

Wilkes wants to reduce the tax burden on working class residents by vastly increasing taxes on the wealthy, she said, citing the example of on-line giant Amazon which paid zero federal taxes in 2019.

"That tax burden comes down on us," Wilkes said.

Much of the 5th District's voter population is Democratic though St. Mary's and Calvert counties are strongly Republican enclaves; Wilkes said she understood she might not receive much support there for her agenda.


"Conservative voters who don't approve of my agenda... should realize it's really the best for everyone.'

China has come under intense scrutiny and criticism for its apparent ill-handling and deceit regarding the dangers of the novel coronavirus but Wilkes said the U.S. should not seek to berate China.

"I don't think we should condemn the Chinese," Wilkes said. "[President] Donald Trump has also not been honest about the virus.

"We should be working with China to make the world a better one."

School Board Buys GPS For All Buses

At their May 20 meeting the St. Mary's County Board of Education approved the purchase of 275 GPS units for school system buses from the vendor Synovia Solutions, which had provided 50 GPS units for special needs and school board owned buses as a pilot program.

This recent new purchase, which will upgrade the 50 in the pilot program with new tablets, was for \$391,875 with a five-year service agreement that leaves the school system in ownership of the equipment.

The initial pilot program leased the gear to the school system; the vast majority of school buses in St. Mary's are contractor owned.

The new tablets will allow parents to know where their students' buses are

via an application they can access on their electronics that is free of charge and will also notify them when their assigned bus is coming to pick up their

Jeffrey Thompson told the Board of Education last week that the system can be expanded to check students on and off a bus and even determine which students should or should not be on a certain bus

"That's down the road," Thompson

He said that the school system could use unspent funds for transportation for the Synovia Solutions upgrades since schools had been closed since mid-March.

"I'm thrilled we'll be able to put this on all our buses," said Board Member Cathy Allen

Budget Hearing Draws No Comments

Record Open for Three Weeks

The Calvert County Board of County Commissioners (BOCC) held a virtual party and no one joined in. The occasion under the 'new normal" was the May 19 public hearing on the Fiscal Year 2021 Commissioners' Budget and the public was encouraged to call in their comments to the ZOOM meeting. No one did.

The BOCC left the hearing open until midnight June 8 in hopes of generating some comments. They are expected to adopt the budget at their June 9 meeting.

The proposed \$318.5 million budget is \$3.5 million less than the one presented several months ago by staff at another public hearing. According to Director of Finance and Budget Tin Hayden, that reduction includes a \$2 million income-tax revenue hit due to the economic impact of the COVID-19 pandemic. They also predict to lose \$1 million in lower interest and dividends. The ultimate fiscal impact is anyone's guess.

The budget includes a slight decrease in the property tax rate, although that rate still falls a little bit above the Constant Yield, the rate the county would charge to generate the same amount of revenue as this year. The proposed rate is \$.932 per assessed \$100 valuation compared to the Constant Yield of .9195.

The proposed budget is \$5.5 million more than the current fiscal year, representing a 1.7 percent increase. Hayden said \$3.6 million of that revenue increase comes for the Payment in Lieu of Taxes (PILOT)

for the Dominion Cove Point Plant. Hayden warns that upward PILOT trend will peak this year and leave the county with a shortfall by Fiscal

Although the tax rate is declining, the budget includes fee increases for Planning and Zoning, water and sewer; and solid waste.

Hayden said the highlights of the proposed general fund budget are:

There is one fewer Full Time Equivalent (FTE) in this budget.

A step increase (i.e., salary increase) for County employees, plus a 1.42 percent cost of living adjustment (COLA)

\$6.2 million is provided to Calvert County's Highway Maintenance Division to fund the road paving program.

The contribution to the capital projects fund: \$10.8 million

Other Post Employment Benefit (OPEB): Funding the OPEB Trust:

County \$3.3 million

Board of Education \$3.9 million (Providing the full Actuarially Determined Contribution (ADC))

Board of Education Funding Changes:

Operating funding for Calvert County Public Schools is recommended at \$134,705,249.3 \$4.1 million or 3.2 percent over the prior year, as determined by the funding formula and \$3.2 million or 2.5 percent over the state required Maintenance of Effort.

During his presentation Super-intendent of Schools Dr. Daniel Curry said his budget has 22 new positions, including new psychologists, psychologist interns, guidance counselors and social workers aimed at stemming the much- reported incidents of violence against teachers.

Curry praised the BOCC for supporting the school system in the last four years with their negotiated budget formula. He noted that negotiations with teachers are still ongoing for the next year.

He said, however, "In order to plan for what may be required, funds are included in the budget to support the negotiated agreements once they ate finalized."

Six Compete for Calvert School Board Seat Candidate Dawn Keen

Dawn Keen, 41, of Port Republic is one of six candidates running for the Commissioner District 2 Calvert County Board of Education sear in the June 2 primary election. The nonpartisan primary will select the top two vote getters to face each other in the general election.

She decided to run, she told The County Times, because "I have two children in elementary school and I have a lot of friends and peers that I grew up with here in the county that are teachers. And I started to hear grumblings and see posts on Facebook about some violence in the schools. And as soon as I learned it was in elementary schools, I was kind of shocked because I was expecting to hear that it was in middle or high school. And the more I learned, the more disturbed that I became, and I decided I wanted to try to help."

Keen was born in St. Mary's County, but her family was from Calvert and they moved back when she was an infant. She attended

county schools and then went on to study business administration with a minor in psychology at Lynchburg College. She moved to Richmond and got into retail, rising to run her own store in Montgomery County. "I was working in retail and decided I wanted to have a more stable position with opportunity for advancement. So, I went to work for the USDA, and I have worked with them for 18 years now."

In her job as a USDA statistician she had to move to Texas. "And I met my husband and two years later my grandmother got sick and we moved back together to Maryland to help care for her. And she unfortunately passed away, and we stayed here and helped with my mother who's deaf."

She was active in PTA and when she heard about the violence, she started attending school board meetings. She said as a statistician what she was hearing in both places didn't add up.

She said, "I'm finding out that some of the incidents that people are ending up leaving their jobs as teachers with black eyes and physical ailments were occurring in the same school and between the same walls that my children were inside of. And according to everyone there was no problem at all."

She said there appeared to be "a wonderful code of code. But it seems like somewhere along the way we've lost touch with what reality is and what's really happening. So, my goal is to try to make some sense of finding the truth in order to help everybody kind of come back together from their two sides of the fence or three or four."

Having deaf parents helped her appreciate "The tribe of disabilities and handicaps and what that entails as far as community resources and the lack thereof and being in a rural area. And having to deal with someone

who needs a little help sometimes or a little guidance and not getting it because of where we live in proximity to the city."

She said out of the infighting, "The only people who are suffering are children in the schools and our teachers and it's just not fair."

She describes the competing factions as tribes, and she said that has led to shootings in schools. "I just fear for my children when they get older and what could happen in our high school if we continue on this trajectory."

Keen was asked if she agreed with the school board pressing for additional funding to attack the problem. "I'm so glad you're asking about that because that's the reaction I'm seeing is that we just don't have enough funding for the resources that we need. And that's overly concerning for many reasons to me."

Keen said, "We've increased our budget for early learning and education in the United States some 325 percent over the last 40 years with zero change. There may be slight change over that time, but nothing to constitute such an increase in spending."

She added, "We spend all this money and it doesn't really change outcome and we put people inside of different buildings and we grouped them differently and there's not always going to be that outcome. So, we need to figure out a way to group people by their abilities like we once did when I was in school. And if you're in a classroom, it doesn't matter if you're black or white or deaf or disabled or whatever you are. If you're able to stay on track with the learning, with peers in your classroom, that's where you need to be. But if you're not, you can't be sitting in that room with those people holding them back. It's just not fair.'

She challenged "inclusion at all costs" and likened it to what's happening with over protecting in the pandemic. "We might be creating a whole lot more of a problem with suicide and other deaths and other issues and we're kind of losing sight of the ball and we have to find somewhere in the middle."

Keen is critical of the legislative implementation of the Kirwan Commission reforms calling for a 400 percent increase in 10 years. "We've just thrown common sense completely out the window," she said.

Regarding the school board controversy about what to do with hoodies, earbuds and cellphones, Keen said, "The whole issue is that the language is there in the code of conduct to be enforced, but for whatever reason it's not being enforced."

She said statistics are being misused to pin the discipline blame on certain types of students.

Regarding the distance learning going on now, she said, "I think it is a really difficult thing for the parents who are working, and not sure that children are really learning much. I think it depends a lot on what content they're viewing. I see that they're reading content that is sometimes beyond their developmental expectation from me as a mother"

She added, "I don't think the online learning is working, the concept of everyone being in the same home as a family. I really appreciate that. But I think it's not going to work out for single moms or dads. We're just all kind of considered in the same boat and we're not; we all come from different walks of life."

School Board Candidate Candidate Antoine White Camille Miller

Camille Miller, 39, of Huntingtown is one of six candidates running for the Commissioner District 2 Calvert County Board of Education seat in the June 2 primary election. The nonpartisan primary will select the top two vote getters to face each other in the general election.

The parent of a special needs child (autism), she said of her candidacy, "I decided to run for the school board because initially I started become more involved on the special needs front. I became a member of the special education advisory council."

She added, "I just saw that there was a gap initially of education and knowledge of the members of the board with regards to the special needs community. I realized there were other skills that I have that I think would be really helpful with some of the issues that they're having around equity and recruiting.'

Miller was raised in the county but attended Anne Arundel County schools. She has a bachelor's in Economics from the University of North Carolina at Chapel Hill and an MBA from Loyola University in Baltimore. She said, "I've been working in the field of human resources my entire career. I'm currently a chief human resources officer for a digital fundraising firm

Miller has four children, three of whom are her biological children who are in county schools.

She said of what's needed for special education: "Just a clear vision of what they want to do with the special education department and curriculum and where they want the students to end up and how they want them to show up in their adult lives. Are we doing programming to help them become viable, tax-paying citizens?"

She added, "I think if they get clear on what they intend for the students in the long run that can help them then to work backwards and develop, redevelop some of the curriculum that they have now."

"It's not that I think that the system is not working at all. I think it just could be more efficient and more viable and more individualistic based on the student's needs."

When asked about blame being focused on special education students for the muchpublicized discipline problems, she said, "I don't agree with that." But then she qualified it by saying, "The numbers are the numbers. I can't say that it may not be that that's the case. But with regards to looking at the question in a different way, I think that a lot of folks really know how to deal with some of the special needs community and some don't. And it's the job of the employer to make sure that the skillset of the employee is where it needs to be for them to serve. And so, there's more training that needs to take place. There's more information that they need to be given. And then those who have the specialized skills need to be the ones that are doing more with those students and with that community so that they're profitable and so that the students are comfortable and so we can have less of these severe incidents and situations.

"I also think that the teachers need to be paid attention to when they are having these severe incidents and situations. From what I've gather, a lot of times when they are bringing things to

light in the earlier stages, it is not being given as much attention as it should."

She was asked about plans to consolidate the Behavior Development Program at one school She responded, think giving it

some focus is definitely a good thing. But on the broader scale, I think it's still a little like trying to address all of the situations in a box. Like on one hand we say as a school system that we're moving towards inclusion and wanting to minimize the amount of the civic programming to try to get more students into the general population, which I think for some students is good. And for some it's bad."

Should inclusion for all students be the goal? She responded: "I think that the goals should be to treat each student as an individual to the extent that you can and gear their education and learning to that effort. She said she learned from her son "every child actually has special needs. They just have it in a different level of intensity

As to recruitment, she said, "I think that the tactics that have been done so far are good. I think that the HR team with CCPS is very motivated on how they're approaching things. But I think that they could gather from their current staff, and from their community to learn more about what can be effective in drawing people to the county. I think we need to own more of what we are, which is we are a small town and it's not always going to be easy for us to get people from big cities, from big schools.'

Salary is a factor, she said. "I think salary carries different weight for different people. But overall I do think that, just as in corporate industries, you have to factor where you're going to fall in terms of salary if you're going to lead or lag or try to meet the market.

Miller said in her election bid she has reached out to the teachers and current board members for guidance.

She feels she will get teacher support. "I'm very much a supporter of teachers and all other staff within the school system and the more I thought about some of the issues and concerns that were being raised within the school system, even my own with my own children, they factor in pretty much every situation for the teachers."

She gives the school system pretty good marks. "I would say overall I've had a very good experience in the school system. I made a very pointed decision to start my children's school careers in this county. I purchased my first home in the county, which was at the point in time when my oldest child was five, so she was getting ready to enter into kindergarten. I decided to come here because the education system was very pleasing to me. And I feel like we've had a really good experience here.'

Antoine White, 49, of Prince Frederick is one of six candidates running for the Commissioner District 2 Calvert County Board of Education sear in the June 2 primary election. The non-partisan primary will select the top two vote getters to face each other in the general election.

White said of his decision to run, "I think that we have a great school system and I think we've always had a great school system and I want that to continue. It just seems like we have a lot of things going on, a breakdown in communications and a lot of disconnects between parents, teachers, superintendent, and board members. I like to think of myself as a bridge between people and help them to understand what comes down from this state to the commissioners, to the school board. And instead of being one of the people on the sideline that is complaining, a talking head, I'd like to have a seat at the table so I can actually try to contribute in any way that I can."

White is a Calvert County native, raised in Adelina, and a Calvert High School graduate. He joined the U.S. Air Force and continued his education there as a civil engineer. He is now a mortgage broker with Universal Mortgage. He and his wife have a son in college and a daughter in 4th grade at Barstow Elementary.

White said he has been on the parent advisory council at Barstow. "I'm very involved and have a great relationship with her teachers. I think that one of the keys is the relationship that you have with the teachers."

White was asked what skills he believes he would bring to the board. He said, "I'm a mediator, an asset development trainer. So, I think conflict resolution is definitely something that I'm skilled in. I've worked with probably a dozen or so organizations in the community and with me being a basketball official, I have relationships with just about every school in the county.'

White said he has been following the controversy over discipline in the schools. He said, "From the conversations that I've had with teachers, administrators, principals and parents, a lot of it seems to be the behavior and the consequences and the safety of the teachers. We have some pretty amazing teachers here in Calvert and we want to keep it that way. In order to do that, we have to make sure that the teachers feel valued and respected."

He was asked if there are policies in place to address the issue. He responded, I think a lot of the policies come down from the state. So, from that we just have to have the principals, superintendent, and members on board to see where they need to be reworked. Without really knowing all the ins and outs, I can't really speak to it too much, but if there's this much controversy and these many issues that we're having, it definitely shows that it needs to be addressed'

As to the request for additional staff (psychologists, guidance counselors, social workers) to address the issue, he said the board being directly involved knows where best to start. "He said, "I've had con-



versations with the superintendent, and he knows that there are areas of expertise that we're lacking. We do need some of these people to help with the solution. And I know we have resource officers in schools also. I don't know if we have enough to really handle all the schools because I think they're on a rotation.'

As to the distance learning going on during the coronavirus pandemic, White said, "My wife and I take turns tag teaming with the online, distance learning. It's interesting to say the least, but I feel that there is a support system there if you have questions that we can reach out to her teachers for help. So, it's actually pretty good. I think it's giving a lot of parents a different understanding of what our teachers really go through.

He admitted it could be a problem for working parents. "We're definitely blessed to be able to do that." He added, "I definitely have talked to a couple of parents who needed a little assistance on getting the laptop set up and matters like that. So, I definitely see that there is a struggle. I guess my concern is for the children who aren't as involved, who don't have someone really pushing them to make sure that they get their assignments done, a gap that that could create later'

White feels sone parents feel disconnected from the school system. He said, "I think it's just when people, I don't know how or why, begin to form their own opinions or reasons and sometimes they are misled by half stories. So, I think there's a level of frustration from some parents and the demands that they place on teachers.'

If elected, he said, "I think one of the main things that I would love to do is to truly find out what's going on in the school system as far as with the teachers. It seems like we have a lot of teachers who are leaving the county or openly saying on social media, venting their frustrations. I think that that would be my first priority is to get to the issue of what the problem is, what's going on with the teachers. "

He added, "But also the kids. We have kids who have challenges. We have kids who do very well. We have to meet the needs of all the kids in our system.'

White said of his candidacy, "Most importantly I hope that I can contribute. Some people just have a heart to serve and that's kind of what's pushed me for the past 30 some years. So that's what I want to continue to do.'

Rebekah Wilmer Jarboe





IS IT POSSIBLE TO AVOID PROBATE?

The short answer is that unless you create a Revocable Living Trust, you cannot avoid probate for property held in sole name, but you can minimize the number of assets that have to go through the probate process to get distributed to your beneficiaries.

Many people want to avoid putting their beneficiaries through the probate process. They don't like the fact that the filings in probate are publicly available or that it takes 8-12months to close a probate. Or, that legal fees in a probate proceeding can be expensive. Additionally, they don't want to leave their loved ones with turmoil when they die. They seek to make it simple. But, they don't want to spend the money to create a Revocable Living Trust.

What can be done to minimize the number of assets that have to go through the probate process?

Since probate applies only to property held in your sole name when you die, you can transfer title of the property to someone else during your lifetime. Or, if you want to continue to maintain some control your property, you can transfer title to yourself and someone else. If you re-title the asset with someone else so that each of you are holding the asset jointly with "right of survivorship", then when one of you dies, the other will inherit ownership of all the asset and there will be no probate.

Keep in mind that if your property is the subject of a mortgage, the mortgage company may restrict your rights to transfer your ownership.

Most commonly, a husband and wife will hold an asset like their primary residence in joint name with right of survivorship (also termed "tenants by the entirety"). This means that when one spouse dies, the other takes ownership of the entire property and there is no probate of the asset since it was held in joint name. Of course, when the survivor dies, there is probate of the asset.

The key issue is how you re-title the assets. If you hold an asset like real property as "tenants in common" with another person and not as joint tenants, that means that you and the other person each hold a one-half ownership interest in the property. When you die, the other person still holds only a one-half interest in the property and your one-half interest will have to go through the probate process to get to your loved ones. For example, when children inherit property and there is no Will to advise how the property should be titled, they will inherit the property as tenants in common, meaning each of them will have an equal ownership share of the

Suppose you own a house and your spouse is deceased, meaning you own 100% of the property in your sole name. You have one child and want to add that child to your title to the property. Can you

add another person, like a child, to your title to the property? Yes, that can be done with a deed. But, there are consequences you must think about before you re-title any property.

The first issue is a tax issue. When you buy a house, your cost is your tax "basis" in the house. Suppose you buy a house with your husband forty years ago for a price of \$20,000 and the house is paid off. Today that house is worth \$200,000. If your husband is deceased and you own the house and add a child to your title, that child receives the property at your tax basis or \$20,000. When you die, if the child wants to sell the property, the child is going to have to pay capital gains tax on \$180,000, being the difference between your tax basis of \$20,000 and the market value of the property, \$200,000.

That tax can be avoided by passing the property to your child through your Will or Trust. A Will or Trust provides a "step up" in basis so the child or beneficiary takes the property at the market value. If the child then decides to sell the property, there is no tax since the child inherits the property at a value of \$200,000 and sells it for the same amount. Of course, that means, unless you have a trust, the property will have to go through the probate process to get the step up in basis and get to your beneficiaries.

The other issue to be faced with putting a child on your title is whether the child has or will have creditors. Once you place property in the name of the child, their creditors become your creditors.

One option to avoid probate is to use what is called "payable on death." Every bank will have a "payable on death" form you can fill out indicating who will take the money in your accounts when you die. By filling out this form and designating a beneficiary to take your accounts, the accounts are not held in sole name and there is no probate on those accounts. The "payable on death" or "Transfer on death" forms can be used for investment accounts as well as bank accounts.

The best approach to probate is to focus on organizing your assets so that your loved ones will not have to search through years of paperwork to try to find out what you own, where your accounts are, what insurance policies you have, etc. To make it simple for your loved ones, you have to do the work upfront. Believe me, your loved ones will love you even more if you leave them with very little to do in a probate proceeding.

Jordan's the GOAT, but

Bi-weekly status check: it has been 78 days since the NBA suspended its season and 22 days since schools shuttered for the year. March 26 was supposed to MLB's opening day. Last May, the Nationals had a brutal-turnedfamous 19-31 record; now, we long for them play again, win or lose. Graduations have gone virtual and workplaces are increasingly remote. We are masked (mostly) and distanced, frustrated yet hopeful, divided yet together. This experience has brought out the best in some and the worst in others. COVID-19 has claimed over 100,000 American lives: too many more will die. This moves many to tears; others are disturbingly numb and defiant (or is ignorant and selfish?). Regardless, this truth is shared: we face many more months living with this virus in a skewed reality

In the meantime, sports limp on, as do the "Views." And being of sufficient vintage to recall both the disco era and the arrival of the NBA's Greatest of all Time (GOAT), I have had the fabulous Donna Summer and the indomitable Michael Jordan on my mind.

You caught the connection, right? "Last Dance" - both a 10-part docuseries on Jordan's Chicago Bulls and Summer's iconic disco song? Anyway, director Jason Hehir's masterpiece on the 1998 Bulls, with fabulous, chronological storytelling of Jordan's career, was a welcomed nostalgia trip and a perfect respite from the COVID-induced sports desert.

My personal ties to Jordan are deep. My first vivid NCAA Championship game memory is North Carolina's defeat of Georgetown in 1982. Jordan, a freshman, hit the winning shot. I remember his games against Len Bias's Terrapins, the first generation of Air Jordan shoes, his 1988 NBA Slam Dunk Contest victory over Dominique Wilkins, his brutal playoff battles with the Bad Boy Detroit Pistons and all... those...championships.

The NBA has changed considerably since 1998. The competition is gentler, effort is inconsistent, offensive approaches are increasingly about isolation and either a three-point shot or a dunk, trophy-hunting stars form superteams and "load management" (taking games off) is an accepted practice.

With that grumpy backdrop, I wanted two things from "Last Dance": first, to accurately portray Jordan as the insane, rip-your-heart-out competitor that he was and, second, settle the GOAT debate once and for all. "Last Dance" delivered on both accounts. Jordan didn't take games off, he was as passionate about defense as his jump shot, the early-career losses to the Celtics and Pistons didn't prompt him to tuck tail, run from Chicago and join forces with other stars, and unlike anyone I've ever seen, he rose to deliver the greatness demanded by the biggest, championship-winning

He's the greatest basketball player

With that settled, an omission: "Last Dance" delivered two "buts" I didn't expect. Jordan's approach taught many life-lessons: the value of determination, hard work, clear focus, staying the course against adversity, not taking the easy way out (superteams), turning slights into motivation, maintaining confidence and an unwavering belief in vourself.

In the moment, Jordan's competitive madness made sense and its effectiveness is unquestioned - six championships. But has it aged well? In a basketball sense, yes; in a human sense, no. Jordan permanently fractured many relationships - with peers of his era and some teammates – in the name of winning. He is now, in many ways, alone at the top.

Jordan seems at peace with this. In his words, "winning has a price...and leadership has a price." True. However, that prompts the second "but" from "Last Dance": why was Jordan only willing to pay that price as a basketball player? With the exception of perhaps Tiger Woods, no athlete has held more global significance than Michael Jordan. He sold a lot of shoes, Gatorade and Happy Meals with that influence. Where was the great courage, determination and competitiveness to adopt an off-the-court cause and advance the world, kicking and screaming, into some better version of itself? As did Kareem Abdul-Jabbar. And Jim Brown, And Muhammad Ali, And, even. LeBron James.

As Spider-Man knew, with great power comes great responsibility. It is fair to have expected more from Jordan. "Last Dance" confirmed that he's the GOAT, but only on the basketball
