Family Demands Answers In Police Slaying of Son

Peyton Ham, 16, was shot and killed by a Maryland State Trooper April 13, who according to his superiors, had been threatened by Ham with what he thought was a handgun

That weapon turned out to be an airsoft pistol.

After months of investigations by the Maryland State Police and the St. Mary's County State's Attorney's Office, Ham's family is still waiting for answers as to why the Leonardtown High School honors student was killed

Ham's family is holding a rally July 17 at the county governmental center in Leonardtown to demand answers.

"We're just hoping justice will be served," said Kellee Raley, Ham's aunt. "We have not forgotten about Peyton.

'Everybody wants answers."

Mike and Kristee Boyle, Ham's parents said the rally would be a peaceful one.

"Just over three months ago, 16-year-old Peyton Ham was shot and killed by a Maryland State Trooper," the Boyle's said. "Saturday's event is a planned, peaceful, rally, intended to remind our locally elected State's Attorney that the community has not forgotten.

Peyton's family has placed their faith in the hands of those officials investigating as most details involving the case cannot be shared with the family due to it being an ongoing investigation."

Deputy State's Attorney Daniel J. White has told The County Times he does not expect to conclude the criminal investigation into the actions of Tpr. Joseph Azzari that day, when he responded to a property mere yards away from the Leonardtown Barrack on Hollywood Road and confronted Ham, until the end of July.

White said he is continuing to wait for the final report from the state Medical Examiner in Baltimore on Ham's autopsy.

Maryland State Police Superintendent Woodrow W. Jones, who held a press conference in Leonardtown the day of the shooting, said the that the trooper arrived on the scene after two anonymous calls reporting "a guy who was acting suspicious who [may have had] a gun."

The trooper confronted the suspect, later identified as Ham, who possessed what appeared to be a gun and a knife, Jones said.

A witness reported seeing the suspect in a "shooting stance" pointing the gun at the trooper, Jones said

"The trooper fired at the male and wounded him," Jones told

reporters. A second witness, Jones said, reported seeing Ham pull out a knife after being shot and attempt to get back up.

"The trooper ordered him to drop the knife before he fired again," Jones said.

The trooper called for law enforcement back up to tend to the suspect while waiting for emergency medical personnel to arrive, said Jones.

By the time Ham was transported to Med Star St. Mary's Hospital, he was pronounced deceased, Jones said.

Witness statements and drone footage suggest the law officer fired multiple rounds, perhaps the entire capacity of his service weapon, when he confronted Ham.

The drone footage available online showed that at least 15 evidence marker flags on the ground, possibly denoting expended shell casings, in three separate, distinct groups.

Also, a witness, speaking on condition of anonymity, has said they heard at least 14 shots fired in the incident in three separate salvos that day.

The trooper's service weapon, a Glock 22, .40 caliber pistol, has a magazine capacity of 15 rounds.

Other neighborhood residents have reported finding bullet holes in their residential property, across Hollywood Road, from where the shooting took place.

Greg Shipley, director of the

Office of Media Relations for the soft pistol collected at the shootstate police, responded to The County Times back in April that such flags could be used to mark many kinds of evidence other than shell casings.

Shipley also said then that he did not release the image of the airing scene because it had blood on it; Shipley did release an image of the knife Ham was alleged to have had, a folding knife with a blade length of about three inches.



Commissioners Pursue Third Early Voting Site

The St. Mary's County Board of Elections has chosen a second early voting site, as required by newly enacted state law, but the Commissioners of St. Mary's County have decided to seek a third early voting site to better serve county residents.

The new law only requires that St. Mary's have two early voting sites, with an option for a third; Del. Brian Crosby pressed for the addition of a second early voting site through legislation to eliminate what he called voter disenfranchisement in the Lexington Park area.

In last year's election, during the COV-ID-19 pandemic, the county was required to have just one early voting center, located at the Hollywood Volunteer Fire Department.

Wendy Adkins, director of the local election board, told commissioners her department had entered into a contract with the Bay District Volunteer Fire Department, located on Shangri-La Drive, as the second site.

Adkins told commissioners there are few suitable facilities in the county that can provide the space required for the thousands of people expected to vote early.

She said 20,000 people came to vote at the Hollywood site last election alone, roughly 20 percent of the county's entire population.

Such facilities also require 25 to 30 people to staff effectively, and who are restricted from leaving the facility for the entire day of the election, Adkins confirmed; the elections board is recruiting volunteers now for the next election as getting sufficient staffing has been difficult.

Adkins said she is considering using the Mechanicsville Volunteer Fire Department's main facility on Hills Club Road as the third site, but that would take the approval of the commissioners, the state election board and the local election board.

Each site is estimated to cost \$200,000 each.

"I have the Mechanicsville firehouse on hold for the northern portion of the county," Adkins told commissioners.

Early voting lasts for eight days before Election Day.

Adkins said any county resident, regardless of their election district, could vote at any of the early voting sites, whereas on Election Day voters must cast their ballots at their designated precinct.

Commissioners Todd Morgan and John O'Connor pushed for commissioners to support a third site to ensure that minority communities other than those normally found in Lexington Park, such as Hispanics, disabled veterans at Charlotte Hall Veterans Home and the Amish and Mennonite communities, also had more convenient access to early voting.

"In the northern end of the county we have an Amish and Mennonite community that far outweighs the [minority] population in Lexington Park, we have a Hispanic population that far outweighs the [minority] population in Lexington Park," O'Connor said. "The only way they can get to these places is to pay someone to drive them in a van [for the Amish and Mennonites]... or their going to have to get transportation from the veterans home. [African Americans]

"The focus has been on one minority group and others have been left by the wayside."

Though the veterans' home was not an early voting site, Adkins said, the local elections board went there in person to collect absentee ballots each election cycle and helped veterans to vote in person by bringing them back to the board of elections.

Commissioner Mike Hewitt was the lone opposition vote, noting in a later statement that he wanted to see how well two sites worked before operating a third.

He also said voting opportunities continued to abound with early voting, absentee ballot applications being mailed to every voter and Election Day itself.

"It's all about what we need versus what's nice to have," Hewitt said.

Fritz Files for Reelection as State's Attorney

State's Attorney Richard Fritz is seeking another term as the county's chief criminal prosecutor; he has served continuously for the past 23 years in that office.

He was first elected as St. Mary's County State's Attorney in 1998. Fritz announced his official reelection campaign July 2 via social media.

"I hope that I have earned your continued support," Fritz wrote. "It is a great honor for me to represent the citizens of this county."

In a July 13 interview, Fritz said he loves his job and "has at least four or five more years in me."

Fritz said he wanted to continue to focus on prosecuting drug dealers, noting fentanyl dealers in particular and also wanted to continue to work closely with the sheriff's office Youth Gun Violence Task Force in getting illegal guns, and those who use them in the commission of crimes, off the streets.

"We look forward to prosecuting these people who carry illegal guns and think they can go around shooting up neighborhoods," Fritz said.

Fritz said he also wants to remain on the job because he expects that Sheriff Timothy K. Cameron, who is serving his fourth, four-year term, will not run again.

"I don't think it's wise to have a brand new sheriff and a brand new state's attorney," Fritz said. "I think there needs to be a continuity of policy."

Fritz is among a handful of candidates who have filed for the 2022 gubernatorial election in St. Mary's.

Commissioner John O'Connor was the first to file, seeking to become the president of the Commissioners of St. Mary's County, effectively vacating his position in Commissioner District 3, which he currently represents.

Marcus Drake, a Mechanicsville resident, has filed to run for the District 2 commissioner seat as a Republican; it is unknown whether incumbent Commissioner Mike Hewitt will run for reelection. None of the other incumbent commis-

sioners have filed for reelection.

Christie Kelly, incumbent county treasurer, has also filed for reelection.

Brewster: COVID Delta Variant Targets Youth, Young Adults

The Delta variant of the COVID-19 virus is now the most prevalent strain of the disease across the country, County Health Officer Dr. Meena Brewster told elected leaders this week, and the youth and young adults of St. Mary's County should be concerned about it.

"It's very concerning," Brewster said of the Delta variant's rise. "It does appear to more contagious and it has a higher attack rate than some of the other variants.

"We're seeing more impacts of severe disease on our youth and young adults."

Brewster renewed her call for those 12 years old and older to get vaccinated if they have not done so already.

"It's [the Delta variant] become the dominant strain in the U.S. due mostly to the unvaccinated, including those not age eligible to be vaccinated," Brewster said. The first case of the Delta variant in Maryland was found in St. Mary's, Brewster said, though that one case is probably one among others that have yet to be positively identified as that particular variant.

Brewster said the health department was working towards gaining better genomic testing abilities to allow it to better identify and track the spread of the variant here.

Despite the rise of the Delta variant, St. Mary's appears to be beating the virus overall.

The county's new case rate as well as other metrics used to track the virus' spread have significantly declined.

"We've definitely enjoyed a slowed down pace of new cases over the past few weeks," Brewster said. "The number of St. Mary's County fatalities has held at 132."

Brewster reported that roughly 53 percent of all county residents have received at least their first dose of vaccine, while about 50 percent of residents have received both doses of a vaccine.

The vaccines deployed against CO-VID-19 are still effective against the Delta variant, Brewster reported.

County Wants Part of Route 5 Named for Sheriff Joe Lee Somerville

The Commissioners of St. Mary's County sent a letter this week to the Maryland Department of Transportation petitioning for a portion of Route 5 be named in honor of the county's – and the state's – first black sheriff.

"The Commissioners of St. Mary's County support the dedication of the approximately 10mile portion of Maryland Route 5/Point Lookout Road from Leonardtown to the intersection with Route 235 in Mechanicsville to former Sheriff Joseph Lee Somerville," the July 13 letter stated. "It is a fitting tribute to the many accomplishments, contributions and legacy of a well-respected, historic figure from our community."

Sommerville served as sheriff starting in 1977, filling out the term of Sheriff George Sanger, who died in office.

He was appointed by then Gov. Marvin Mandel and was sworn in at the courthouse steps in Leonardtown.

He was 37 years old; Sommerville won reelection in 1978 and served until 1982.

Somerville, according to the missive, was also the first African American deputy to serve in St. Mary's, his home county, when he joined the agency in 1966.

Somerville passed away Apr. 1. He was 81 years old.

The route proposed by the county commissioners memorializes Somerville's duties performed on the job as well as his memory.

"This particular stretch of roadway encompasses the route that he patrolled during his duty as deputy sheriff and runs past his former home in Loveville where his family still resides today.

"Sheriff Sommerville was a lifetime resident of St. Mary's County and a dedicated law enforcement officer whose contributions and accomplishments deem him more than worthy of this honor and recognition."

Alcohol Beverage Board Delays Delivery, To-Go Service Approval

The St. Mary's County Alcohol Beverage Board held off this week on voting to opt into provisions of a piece of legislation recently signed into law by Gov. Larry Hogan, HB 12, that legalizes carry out of alcoholic beverages. with some restrictions, as well as delivery.

Instead, the board directed their staff to create regulatory language that coincided with the authority of the bill, which the entire board could consider at its Aug. 8 meeting.

The law codifies emergency executive orders from Hogan during the COVID-19 pandemic that helped alcohol beverage licensees continue to operate their business in the absence of in-person customers.

The law does not automatically take hold but must first receive the approval of the local beverage board

Members of the beverage board briefed the Commissioners of St. Mary's County on the legislation's potential effects several weeks ago, stating their concerns that it could encourage more drinking and driving as well as being

difficult to enforce rules of consumption of alcohol, particularly through delivery services.

Board members continued to debate HB 12's merits at their July 8 meeting.

Legal counsel for the board said any regulations the board made stemming from the legislation's authority could be withdrawn if they proved problematic.

"Like any other regulation, the board would have the right to rescind that regulation," said Christopher Beaver, the beverage board's attorney.

"I think that's an important point here," said David Willenborg, board chair. "That there is a reset button.

"I think I'm in favor of this... there are some busithat need help." nesses Willenborg noted the board could still control the amount of alcohol a licensee could sell either by delivery or by carry-out.

Licensees would still have to apply for a permit to engage in those practices from the board, Willenborg said.

Only licensees who can serve prepared food are eligible to take part under the law.

Town Services Restored After Cyber Attack

After a week's worth of restorative work on the Town of Leonardtown's computer systems, their ability to provide all services to town residents has been fully restored.

Last week the town government was left reeling from a ransomware attack that was part of what could be the most widespread global ransomware attack in history.

Rebecca Sothoron, town treasurer, said the office staff was 'working almost normally" as of July 14, with some customizations

of personal work stations that needed to be reinstalled.

Also computers at the town's waste water treatment plant on Van Wert Lane also had to be restored with new software.

"We've been slowly coming back system by system, since Monday," Sothoron said.

All the town's utilities bills had been processed, she said, and should be sent out by July 16 to all town residents.

"That was what affected our customers the most," Sothoron said



Heritage Area Grants Awarded in Southern Maryland

The Hogan administration announced July 9 that 116 matching grants totaling \$5.03 million were awarded to Maryland nonprofits, local jurisdictions, and other heritage tourism organizations by the Maryland Heritage Areas Authority (MHAA). Of them, 11 were awarded in Southern Maryland with grants totaling \$326.217. These grant funds support heritage tourism projects and activities that draw visitors and expand economic development and tourism-related job creation throughout Maryland.



Maryland State Income Taxes Due, July 15

Comptroller Peter Franchot reminds taxpayers that Maryland state income taxes are due, July 15, after a 90-day filing and payment extension, which was the most generous in the nation.

"Many Marylanders were hit hard by the pandemic, so extending the deadline was the compassionate and commonsense thing to do," Comptroller Franchot said. "If you're unable to pay what you owe, our agency will help you set up a payment plan, but you must file and pay what you can by July 15."

In March, the Comptroller extended the deadline by three months due to the economic impacts of the COVID-19 pandemic, as well as state and federal legislation that required extensive changes to 2020 tax forms in the middle of the filing season.

No interest or penalties will be assessed if returns are filed and taxes owed are paid by July 15. The extended deadline applies to 2020 individual, fiduciary and corporate income tax returns, as well as 2021 first and second quarter estimated payments.

Individual taxpayers who filed a federal extension automatically get a state extension, with both lasting until October 15. If you expect to owe the state money, that payment must be submitted by July 15 to avoid being assessed interest and penalties. If a taxpayer did not request a federal extension and more time is needed to file state taxes, follow the instructions on Form PV. Filing this form extends the time to submit taxes, but does not extend the time to pay.

Comptroller Franchot recently announced a temporary, automatic waiver of interest and penalties for pass-through entities (PTEs) filing and paying their 2020 income taxes by September 15, 2021. The waiver was a result of legislation passed during the 2021 legislative session that required revisions to the 2020 PTE forms. The waiver applies to late payment interest and penalty that otherwise would have been incurred on payments made after July 15, 2021 if the 2020 returns are filed and tax is paid by September 15, 2021. PTE filers who need additional relief may send requests to PTEREQUEST@Marylandtaxes. gov.

Taxpayers who need assistance filing taxes or with other tax-related questions can get help from agency staff in person or virtually. The agency's 12 branch offices are located in Annapolis, Baltimore, Cumberland, Elkton, Frederick, Greenbelt, Hagerstown, Salisbury, Towson, Upper Marlboro, Waldorf and Wheaton. Appointments are strongly encouraged. Virtual appointments can be scheduled at www.marylandtaxes. gov and clicking on the "Locations" tab.


Home Invasion Under Investigation

Farmer Mini-Grants Announced

The Southern Maryland Agricultural Development Commission (SMADC) announces the 8th Round of the Southern Maryland Farmer Mini-Grant Program.

SMADC will begin accepting Mini-Grant applications on July 15. The Mini-Grant closes on September 1, 2021, with awards announced by October 15, 2021.

The Mini-Grant program aligns with SMADC's mission 'to support farms and the future of agriculture in Southern Maryland and is designed to assist new and beginning farmers who own or lease existing agricultural properties with small start-up projects, and to assist experienced farmers who are looking to diversify or expand a current agriculture project. The projects should be simple in scope and must be successfully completed within one year.

SMADC awards will be up to \$2,000 per applicant and is a oneto-one match by the farmer. A total of \$40,000 in funding is available. However, it is anticipated that the number of applicants may exceed the amount of funding available, therefore grant applications will be ranked and awards may be less than the requested amount.

Grant funds may be used for

equipment/services that help transition a farm's sales strategy (such as online sales, home delivery, onfarm sales, etc.), for other projects that allow the farm business to maintain and/or expand sales, for the purchase of foundation livestock, purchase of plant stock, marketing and promotion of current farm operation, new fencing, hoop house, and materials needed for value-added food production and on-farm upgrades to enhance food safety.

"The Mini-Grant program has become very popular with Southern Maryland farmers, and has awarded \$157,007 to 101 farm projects over the previous seven rounds", says SMADC Director, Shelby Watson-Hampton. "The farmers we work with are innovative, creative, and passionate, and we look forward to seeing what new and creative project ideas come through in the applications for this next round."



Leonardtown Looks To The Water

Leonardtown is working to quickly recover and reopen for business as the county is ready to leave the COV-ID-19 pandemic behind and it's looking to the water to boost its success.

The county's tourism arm, Visit St. Mary's, and a local charter boat captain are partnering with the town to take full advantage of its wharf and growing docking amenities there as well as its scenic vista of Breton Bay.

Visit St. Mary's new director, Barbara Sopato, is working on a comprehensive plan to boost tourism throughout the county and that includes Leonardtown.

"Leonardtown is a very important part of it," Sopato told The County Times. "I feel it's vitally important.

"It's such a hub for restaurants, the arts, all kinds of activities and of course there's the wharf."

Supporting the new boat tours that Capt. Phil Langley of Fish the Bay Charters is offering is just one more reason for tourists, and county residents who have long felt little reason to visit Leonardtown, to discover it, Sopato said.

"We have a solid amount of limited-service hotels in St. Mary's but they're not really destinations," Sopato said. "Leonardtown, thankfully, has a newly opened hotel." Leonardtown has the restaurants, shops and other amenities that make the town a destination tourists want to come to and spend more than just an afternoon.

"That's how we measure success, is through overnight stays," Sopato said.

The hotel, located on Park Avenue, also has a trolley that can take guests to different destinations in town, making shopping and vacationing easier.

Sopato said such a transportation system could be expanded to bring people from all over the county to Leonardtown and around town once they arrived.

It was one part of her vision to aid tourism and economic growth there, she said.

But the boat tours, she said, were a way to distinguish Leonardtown from other destinations as much of the nearby shoreline was largely undeveloped and perfect for sightseeing.

"I absolutely think it's a winner," Sopato said of the tours and the town's focus on its maritime assets. "The water is a great distinction for St. Mary's County and it's a great distinction for Leonardtown."

Leonardtown's walkability is also an asset, Sopato said, as people were anxious to get back out and socialize after more than a year of social distancing restrictions and stay-at-home orders.

"The trend right now is going outside and staying outside," Sopato said. "There are a lot of people who have lived in Leonardtown who've never been out on the water there. "It gives people the perspective of the beauty here."

The water tours will be operating through October, she said, so passengers will get to see the county's shorelines change seasons.

"I can't wait to get out there and see the fall colors," Sopato said.

Langley said Leonardtown's location made it an ideal hub for boat tours.

"I've been considering doing it for a few years," Langley said of operat-





ing out of the town's wharf property. "I think it was underutilized."

The wharf has become a popular spot for weddings, various events, boating and kayaking; the town is pushing ahead with more amenities there including more docking slips for visiting boaters.

Langley's route for boat tours takes passengers from the wharf looking out over Breton Bay, out into the Potomac River and out on to the west side of St. Clements Island, where colonists from England first landed in 1632.

Water taxi tours from the St. Clements Island Museum to the island are offered by the county but they do not take visitors to other parts of the island, just to one embarkation point directly across from the Coltons Point shore.

"It's getting people on the water and experiencing some of that history of St. Mary's County," Langley said.

In recent years Leonardtown has been trying to reclaim its connection to the water; generations ago it was a major hub of commerce and transportation involving significant boat traffic. The wharf was also a center for entertainment and nightlife with a restaurant, bar and many other amenities, the restaurant fell victim to a fire decades ago and the amenities there never fully returned.

The town has long sought to attract a restaurant there, and though it is still working toward that goal, it has found a vendor willing to operate a food concession stand at the kiosk at that property.

Langley has been running the tours for about a month and said of the comments about the service that "90 percent of them are very positive."

Weather and sea conditions can be a factor in how long a tour is able to last – normally they are two hours in duration – but sometimes that is also dependent upon his passengers on board the Linda S.

"Not all of my passengers have sea legs," Langley said. "But there seems to be quite a bit of interest in it."

The partnership with the town, Visit St. Mary's and Langley has been a beneficial one for him, he said.

"It's a win-win situation," Langley said. "I'm excited; I've got generations of history here in St. Mary's County and I like to share it."

Laschelle McKay, town administrator, said the town was well situated to make a post COVID-19 recovery, which was already underway.

"We've been working on getting people back into town," McKay said. "COVID did us a favor in that people heard about us.

"They've discovered us now because of the outdoor seating [in front of restaurants and bars.]

Leonardtown fought hard in the early days of the pandemic to get such seating approved with the aid of the county's Alcohol Beverage Board, which helped bring customer back to beleaguered small businesses throughout the town.

The town council declined to purchase a paddle boat last fall that would have conducted similar tours, but McKay said Langley's service allowed Leonardtown to continue to use its waterfront to prosper from tourism.

"While everyone didn't agree with the paddle boat, there is buy-in from everyone that we should have more activities near the water."



Aerial Targets Program Office Changes Leadership

The Aerial Targets program office (PMA-208) welcomed a new program manager during a ceremony July 1 at the Patuxent River Naval Air Museum.

Rear Adm. Brian Corey, Program Executive Officer for Unmanned Aviation and Strike Weapons (PEO (U&W)), presided over the change of command ceremony that transferred leadership from Capt. Molly Boron to Don Blottenberger.

"This program office has developed some amazing payloads that give our surface warriors and our air warriors (of all services) a very challenging presentation," Corey said. "Molly and her team arose to the challenge each and every time."

Since July 2018, Boron has led a team of over 300 personnel and was responsible for a \$1.6 billion program that supplied relevant aerial targets, target control systems, augmentation systems and threat simulation payloads for major combat weapon system test and evaluation (T&E), U.S. Fleet Forces Live Fire With a Purpose (LF-

WaP) training, and Foreign Military Sales (FMS) partners.

Under her tenure, BQM-177A achieved initial operational capability and the target was delivered to the first operating activity at Pacific Targets and Marine Operations (PTMO) at Naval Base Ventura County in California. Her team is currently on the cusp of completing the fourth and final operating activity BQM-177A transition.

PMA-208 played a part in USS Ford (CVN-78), DDG-1000, Standard Missile, Rolling Airframe Missile, and Evolved Sea Sparrow Missile development programs, as well as Rim of the Pacific (RimPac), Formidable Shield and other major U.S. naval exercises Boron also led introduction of the GQM-163A target capability at NASA Wallops and Hebrides, Scotland, providing high-end training to U.S. Fleet Forces and 6th Fleet and increased launch capacity at Point Mugu Sea Range by installing a 2nd MK-7 launcher.

Boron will now support NAVAIR's (U&W) as deputy program manager Inspector General Office.

"I could not be prouder of the men and women of PMA-208. As a team, we established new subsonic and supersonic capability and capacity," said Boron. "Our products are key enablers to PEO Integrated Warfare Systems combat weapon system test and evaluation and deploying ships' readiness. The team has leveraged their talent and invested incredible hours into our aerial and land targets, target systems, the stand up of new operating sites, and the training of fleet operators."

Blottenberger takes command after recently serving as the deputy program manager for the Precision Strike Weapons program office (PMA-201). A Maryland native, he graduated from University of Maryland with a bachelor's degree in mechanical engineering in 1994. He has more than 25 years of experience as a civil servant supporting NAVAIR. Blottenberger has served in multiple roles in the F/A-18 program office and within PEO

for the Unmanned Carrier Aviation and Tomahawk program offices.

Without a doubt, the targets community is talented and poised to meet the demands of our Navy," Blottenberger said. "Targets will be ready to play its part in shaping our Navy as we deal with the uncertainties of the next 10 years. Together we will work to grow each other from good to great as we continue to pursue excellence while building the targets community of tomorrow."

PMA-208 provides threat representative aerial targets, such as the GQM-163A supersonic sea-skimming target, AQM-37D, BQM-34S, BQM-74E, BQM-177A and QF-16 Full Scale Aerial Target, to replicate numerous antiship cruise missiles and other airborne threats. Additionally, the program office provides augmentation systems, threat simulation payloads and target control systems - all of which allow targets to be configurable, tracked and controlled.

Tackle Box Fishing Report 48th Annual Governor's

Cobia fishing is rocking along at a good pace. There are lots of cobia seekers and lots of chum lines, so it is inevitable that some will make a good strike and land several while others get skunked. Try to get out on a weekday when the traffic is less dense. Live eels are the trick.

Trollers are finding some cobia using surgical eel lures. There have been blue fish in the 18 to 25 inch range taking these lures. Some have caught a dozen or so of these toothy critters.

Cobia are located in the Mud Leads, below the Target Ship, and most anywhere in the Triangle.

Spanish mackerel are also in the lower bay mixed with blues.

Rockfish are available for lure casters. The Maryland summer closure starts on July 16 and lasts until the 30th. The Potomac cloure is already in and lasts until Aug. 21.

Spot are everywhere. If you can see water you are in the presence of spot. They will take the new Lugworms, bits of squid, shrimp, nightcrawler, etc, The favorite bait for spot 'bloodworms are in short supply. There have been no shipments of bloods from Maine since the Fourth of July. Bad tides, heat, and labor shortages are blamed. The Fishbite manufacured bait is an excellent substitute.

Perch fishing is excellent in the rivers. The perch fishing in the creeks has been good, but not like it should be. The lack of tide flow, abundace of nettles, and stained water due to rain fall has sent a lot of perch to the cleaner water in the deeper rivers. A break in the heat and some dry days will change that soon.

Tiny puppy drum like the heat and stain and are prevelant in the creeks taking most any bait or lure. Release them carefully. I have heard of a handful in the legal limit slot range of 18 to 27 inches.

There are reports of flounder at Point Lookout Bar and at Cornfield Point in the Potomac. Drift with live minnows and be prepared to catch lots of little ones that have to be thrown back for evey one of legal size.

48th Annual Governor's Cup Yacht Race Sets Sail


St. Mary's College of Maryland's highly anticipated Governor's Cup Yacht Race, scheduled for July 30-31, is open for registration.



FINANCIAL FOCUS HOW DOES SOCIAL SECURITY FIT INTO RETIREMENT?

Here's something to think about: You could spend two, or even three, decades in retirement. To meet your income needs for all those years, you'll generally need a sizable amount of retirement assets. How will Social Security fit into the picture?

For most people, Social Security won't be enough to cover the cost of living in retirement. Nonetheless, Social Security benefits are still valuable, so you'll want to do whatever you can to maximize them.

Your first move is to determine when you should start taking Social Security. You can begin collecting benefits when you reach 62 – but should you? If you were to turn 62 this year, your payments would only be about 71% of what you'd get if you waited until your full retirement age, which is 66 years and 10 months. ("Full retirement age" varies, depending on when you were born, but for most people today, it will be between 66 and 67.) Every month you wait between now and your full retirement age, your benefits will increase. If you still want to delay taking benefits beyond your full retirement age, your payments will increase by 8% each year, until you're 70, when they "max out." Regardless of when you file, you'll also receive an annual cost-of-living adjustment.

So, when should you start claiming your benefits? There's no one "right" answer for everyone. If you turn 62 and you need the money, your choice might be made for you. But if you have sufficient income from other sources, you're in good health and you have longevity in your family, or you're still working, it might be worthwhile to wait until your full retirement age, or perhaps even longer, to start collecting. Another key consideration is

Another key consideration is spousal benefits. If your own full retirement benefit is less than 50% of your spouse's full retirement benefit, you would generally be eligible to claim spousal benefits, provided you're at least 62 and your spouse has filed for Social Security benefits.

Survivor benefits are another important consideration. When you pass away, your spouse would be able to receive up to 100% of your benefit or his/her own retirement benefit, whichever is higher. Thus, delaying Social Security could not only increase your own benefit, but also the benefit for your surviving spouse.

An additional issue to think about, when planning for how Social Security fits into your retirement, is your earned income. If you're younger than full retirement age, your benefit will be reduced by \$1 for each \$2 you earn above a certain amount, which, in 2021, is \$18,960. During the year you reach full retirement age, your benefit will be reduced by \$1 for each \$3 you earn above a set amount (\$50,520 in 2021). But once you hit the month at which you attain full retirement age, and from that point on, you can keep all of your benefits, no matter how much you earn (although your benefits could still be taxed).

One final point to keep in mind: The more you accumulate in your other retirement accounts, such as your IRA and 401(k) or similar employersponsored plan, the more flexibility you'll have in managing your Social Security benefits. So, throughout your working years, try to contribute as much as you can afford to these plans.




