Town Council Approves New Water Park Plan

Contract to be \$18.56 Million; to Open in 2027

It's a big project for a small town. After almost a year of deliberation, the Town Council of Chesapeake Beach is moving ahead with building a new water park to replace the existing aging one at a cost of \$18.56 million.

Funding for the project will come from "reserve funds, grants and financing," according to Town Administrator Dr. Samelia Okpodu.

The motion at the Oct. 16 town meeting that set everything in motion said, "The Council authorizes Town staff to prepare and negotiate a Design/Build contract with Scheibel Contracting and Paddock Pools to replace the existing Water park with a maximum not to exceed price of \$18,568,560.00 (total price with alternates.) Town Council further authorizes the mayor to execute the contract upon approval of the form of contract by the Town Attorney."

Mayor Bruce Wahl told The County Times that the contract had already been agreed to with Scheibel Contracting although it has not yet been signed.

Wahl said Scheibel would act as the general contractor with Paddock Pools as a subcontractor. Paddock built the original water park and the town wanted to have them involved because of their institutional knowledge.

It is not clear whether the details of the contract will be brought back to the council before the contract is signed by the mayor.

The goal is to have the park ready for opening in 2027, a year later than the mayor's original goal.

The decision is a major pivot from plans of the previous council to demolish the water park and replace it with a community swimming pool.

Wahl said that the decision was allowed under the recently amended town code to "waive the procurement requirements for the Water Park Rebuild project. This waiver and authorization is supported by the following findings.

"Number one, the public interest is served. The public has expressed a desire for the water park to reopen in a design similar to the existing facility. This rebuild is aligned with the will of the electorate and the priority of the newly elected town council. Engaging the original builder expedites the process and reduces costs, thereby serving the public interest.

"Number two, competitive procurement is not advantageous. The Public Works director has investigated the feasibility of the rebuild and consulted with multiple vendors, including the original builder. Based on this investigation, it is determined that a competitive procurement process would not be expected to yield a more advantageous contract due to the complexity of the site-specific nature of the project.

"And number three, justification for vendor selection: Paddock Pools, as the original builder, has unique technical knowledge of the structure and its historical issues. Their

expertise enables a targeted rebuild that minimizes unnecessary demolition and allows for infrastructure reuse, recycling, significant savings, and long-term durability.

Five of the six council members supported the motion, with Councilman Eric Reinhardt the lone member not going along with the majority.

Reinhardt said, "It's cut and dry. It's either going to pass or fail and we move on really quickly."

But Reinhardt added, "I still would like to sever the approval of the authorization to negotiate from the authorization to execute." An attempt to do so failed for lack of a second.

Earlier in the meeting several people spoke in support of the new water park. Shirl Henley said of the water park, "It's been a bright spot in our community for all the years that I've been here and even before. And I'm hoping that it's going to be a bright spot for years and years afterward."

Henley said, "Everything is expensive now. We have to live with that, but if you look around, we do not have a lot of amenities for people in the town, especially young people (and) older people. The water park is something that we can all use."

Nadine Jarrett said, "I've worked at the water park for about 20 years. I've been around young people for a very long time, and the water park was a very integral part of our young people's lives here, and I'm hoping that that will continue to be that way. We did more than just have employees. We have some of

them here now that worked from the time they were 14 years old, and they've worked their way up and they became responsible adults. They worked in an environment where they were taught what they needed to do to work out in the public. They learned how to work with people. They formed skills that they wouldn't have gotten anywhere else. And they've been missing that. That's something that we have been missing."

She observed, "We've been missing the time when the kids would have a place to go in the summertime. And beaches around here are closed everywhere. Nobody can go to a public beach anymore. You have to pay to go to beaches. The kids need a place to be."

Jarrett added, "Even businesses in the area suffered because the water park has been closed. It's been a great impact on this whole area. (at) the water park, families could come there with their kids. They didn't have to drive somewhere else. They could do it right here in our town. And that's what makes our town so special. And we've missed all of that. People came from everywhere. When working over there, people said...they were from Pennsylvania. Heard about your water park. I wanted to be there. So, I'm hoping that you'll move forward and make it possible again for young people to be employed, to have a place where they can grow up and enjoy being here right in their own town and enjoying those things because they've missed that."

Supplemental Budget Adds Almost \$3 Million

The Calvert County Board of County Commissioners (BOCC) has approved a supplemental budget for the fiscal year that ended June 30. The budget adds almost \$3 million in expenses offset by an upward readjustment in anticipated income tax revenue.

The approval came at a public hearing at which only one speaker, Joseph Cormier of Owings, testified.

Before the hearing "Deputy director of Budget Mary Andes read a memo to the commissioners that said, "On June 10, 2025, the Board of County Commissioners adopted the Fiscal Year (FY) 2026 budget, which appropriated \$385,978,812 for General Fund operating expenses."

She added, "Over the past month, the Department of Finance & Budget has worked with county departments to identify items that were either underfunded or unfunded in the FY 2026 adopted budget. The following items have been classified as critical needs and support the case for a supplemental budget:

1. Snow & Ice Removal — The Department of Public Works — Highway Maintenance requires an additional \$255,000 to supplement the existing \$55,000 appropriation for snow and ice removal. These funds are needed to retain private contractors for winter storm response. Without this

funding, the department will be unable to secure contractor availability during snow or ice events.

2. House Bill 352 — Teacher Retirement Pension Pursuant to House Bill 352, Calvert County is required to contribute \$1,650,000 to the Maryland Teacher Retirement Pension System in FY 2026. This is a mandated payment established by the State and must be met in full.
3. Prudent Rx Program — In FY 2026, the BOCC approved the implementation of Prudent Rx, a benefit that covers specialty medications not included under the standard prescription plan. Based on projected participation, Finance & Budget recommends an initial allocation of \$75,000. Actual expenditures will be reviewed and refined for FY 2027.
4. Mosquito Control — The Department of Public Works Mosquito Control program requires \$45,500 to continue operations through FY 2026. This request addresses a funding shortfall and ensures uninterrupted service to citizens. Finance & Budget will coordinate with Public Works to ensure adequate recurring funding beginning in FY 2027.
5. Animal Control — Department of Public Safety requires \$17,500 to complete the lighting package installation for an Animal Services vehicle purchased in FY 2025. Without this, the vehicle cannot be placed into service.

The department does not have sufficient funds within its FY 2026 operating budget to absorb this cost.

6. Detention Center — Wellpath. The detention center requires an additional \$750,000 to cover contractual increases in inmate healthcare services provided by Wellpath.

7. Public Safety Master Plan — The Department of Public Safety requires \$200,000 to fund the development of their new Master Plan.

Total cost of the seven items is \$2,993,000.

Regarding using income tax revenue to cover the expenditures, Andes said, "Calvert County has historically adopted conservative revenue estimates to safeguard against year-end shortfalls. Based on recent performance, a revenue increase of \$2,993,000 is both reasonable and sustainable. Even with this adjustment, revenue estimates remain conservative and will not create a deficit."

Commissioner President Buddy Hance said, "So, the last couple years we've had some pretty tight budgets, so we've been cutting and holding everybody to a pretty tight string."

Hance noted, for example, "Last year, I believe...we had one of the snowiest winters we've had in quite a while. So, we were prepared that we might have to make a budget adjustment to cover that additional expenditure which we have no control over."

He added, "The House bill for the Teacher Retirement Pension, that's an item that the

state pushed down on us. At the time of our budget adoption, we didn't know what that was. So, we have to come in and make this adjustment based on that push down cost, which is probably going to happen again this coming year."

He went through the rest of the items providing justification.

Sheriff Ricky Cox said inflation is the issue for the Wellpath program for "the cost of the care and security and protection of the inmates that are at our detention center. Just for one example, the one contract was paying registered nurses \$13 an hour. Any nurse that goes through school realizes that's a downfall for them."

Andes said, "All of these items we unfortunately could not prepare for when projecting the FY 26 budget. So, this really is the best fiscally responsible way to do it. We're using FY '26 funds to pay for FY '26 services."

Commissioner Catherine Grasso said, "Just before people get up and talk about how horrible we are at budgeting, I just want the public to understand that a budget is just a projection. And you base it on historical information. You base it on the information that they had at the time you developed that budget. And when you're cutting budgets, like we've been cutting budgets the last couple years, we anticipate things like this. But we're trying to hold our departments on as close a shoestring as we can."

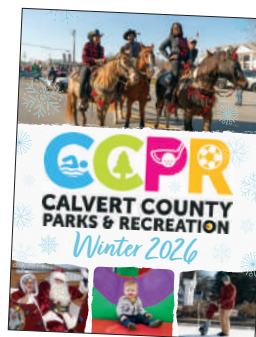

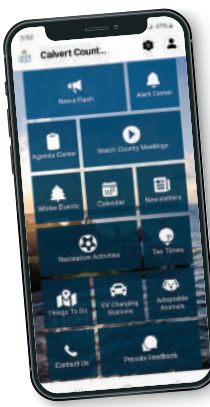

Hall Aquatic Center to Close for Construction

HVAC System, Roof, Lighting to be Replaced

The county's Edward T. Hall Aquatic Center in Prince Frederick will be closed for six months beginning next May for a major renovation that includes new HVAC system, roof, and lighting. The closure has raised concern about options from the people who use the indoor facility.

Director of Parks and Recreation Bob Branham, in a memo to the commissioners, wrote, "The Edward T. Hall Aquatic Center requires replacement of its aging HVAC systems and the installation of a new Thermoplastic Polyolefin (TPO) roofing system. These upgrades are necessary to maintain the safety, efficiency, and long-term viability of the county's primary aquatic facility."

He went on to say, "Calvert County is utilizing the Sourcewell Indefinite Delivery-Indefinite Quantity (IDIQ) Contract No. MD R4-GC-030425-CCE with Centennial Contractors Enterprises Inc. to complete this project. Centennial has provided a final detailed scope of work and proposal, dated Aug. 27, 2025, for the replacement of the HVAC systems and TPO roofing. The proposal includes all required mechanical, electrical, roofing, and scaffolding work. Work Order No. 143818 establishes a firm, fixed price and includes liquidated damages of \$500 per day for delays beyond the agreed schedule. The total cost of the project is \$5,809,450. Funds are budgeted and available for this project within the Capital Improvement Plan CIP-000105: Hall Aquatic Center HVAC/Roof Replacement."

Branham said, "Without these upgrades,

the center faces potential closures, safety concerns, and loss of public trust, with each shutdown averaging \$21,000 per week in lost revenue. Proactive replacement will preserve the facility's integrity, reduce future costs, improve energy efficiency, and ensure compliance with safety and health standards."

Branham said, "Since opening its doors back in 2010, the Edward T. Hall Aquatic Center has made a splash in our community. We continuously welcome swimmers, athletes, families, and friends for 15 incredible years of fitness, fun and connection. This facility, like many parks and recreation amenities, has been a gathering place for our community. Like any well-used and well-loved facility, it's now time for some much-needed TLC to ensure it continues serving Calvert County residents for decades to come." He said, "The Edward T. Hall Aquatic Center renovation will focus heavily on core infrastructure renewal. This is the HVAC system, roof structure, and lighting systems, which are each undergoing full replacement to bring the facility

up to modern standards. The new HVAC system will provide improved air handling and humidity control, addressing both comfort and corrosion prevention. Currently, the facility's HVAC system is operating at less than 50 percent of the required capacity to adequately heat and cool the facility. This is most notably felt during periods of intense heat and cold. But issues are also being shared daily based on the warm days and cool nights of the fall season here currently. Many of the people in this room have frequently heard from county residents and user groups about the ongoing heating and cooling issues in the aquatic center.

"Notably, last spring, a swim meet had to be canceled because the current HVAC system was unable to properly cool the facility to meet required thresholds. More recently this fall errors in the control system, faulty equipment and incorrectly operating sensors sent temperatures inside the facility soaring."

"The roof replacement," he said, "will strengthen the building envelope, improve insulation, and ensure long-term resilience

against environmental elements. The current roof structure cannot function as it was originally intended. When the facility was designed, the roof panels were configured to provide additional ventilation via moving panels that could be opened and closed. Due to mechanical issues, parts no longer being available, the overall age of the roofing material and the roofing slope, ongoing repairs for these features was just deemed unjustifiable."

The department plans to use Kings Landing and Cove Point outdoor pools as the backup for the time when the aquatic center is closed. Both of those pools will open on May 1 instead of Memorial Day and remain open through September to accommodate the swim clubs, such as 160-member Calvert Aquatic Club.

The commissioners were told every effort would be made to accommodate all the users, but not everyone will get what they feel they need. Some programs, such as the therapeutic program, may have to be cancelled next summer.

The commissioners, having heard complaints from the swim club, pressed the parks and recreation representatives on making sure that arrangements are made to accommodate everyone possible. It was also suggested that the department contact the pool at Naval Air Station Patuxent River to see if times might be available.

The commissioners did unanimously approve the contract for the aquatic center work. Branham said there is a large lead time for ordering materials, so that has commenced so everything is ready when construction begins.

Economic Development Hosts Farm Tour

Local and state officials explored Calvert County's agricultural landscape during the annual Calvert Farm Tour, hosted by the Calvert County Department of Economic Development on Wednesday, Oct. 22. The 2025 tour, themed "Agriculture's Impact on the Economy," brought together policymakers, local producers and agricultural partners to highlight the evolving landscape of Calvert's farming industry.

This year's tour focused on the northern end of the county, with stops in Owings and Dunkirk. Participants visited Wilson Dowell Farms, Freedom Hill Horse Rescue, Sassafras Farms and Swann Farms.

Participants included Maryland Secretary of Agriculture Kevin Atticks, Commissioner President Earl "Buddy" Hance, Commissioner Vice President Todd Ireland, Commissioner Mark C. Cox Sr., Commissioner Catherine M. Grasso and County Administrator Linda Turner.

Representatives from the Maryland Department of Agriculture, the Southern Maryland Agricultural Development Commission, Maryland Farm Bureau, Calvert Farm Bureau and other local resource partners, organizations and businesses also attended.

"Each year, the Farm Tour offers a unique opportunity to connect with the people and

businesses driving Calvert County's agricultural economy," Economic Development Director Julie Oberg said. "This year's focus highlights the diversity of our farms and their critical role in sustaining both our economy and community."

As part of the tour, Atticks hosted a roundtable discussion with local producers at Sassafras Farms. The tour featured visits to agricultural businesses throughout northern Calvert County, including:

- Wilson Dowell Farms (wilsondowellfarms.com): A fourth-generation, 320-acre family farm rooted in the Dowell-Leavitt legacy, where the name honors their grandfather, Wilson Dowell Jr. Originally a tobacco farm, it has transitioned over the decades into a sustainable, pasture-based livestock operation. Under the leadership of Judy Leavitt—and later her son Jason and his wife, Kristen—the farm has shifted to raising grass-fed beef and pasture-raised pork through rotational grazing and regenerative practices. Established as Wilson Dowell Farms LLC in 2010, the farm sells meat directly to consumers and participates in local agricultural education and events.
- Freedom Hill Horse Rescue (fhhr.org):

A nonprofit rescue founded in 2004 by Melody Trecartin to rescue foals from the pregnant mares' urine (PMU) and nurse mare industries. Freedom Hill has expanded to rehabilitate and rehome abused, neglected, abandoned and owner-surrender horses. The rescue has helped more than 470 horses and is verified by the Global Federation of Animal Sanctuaries. Operated by volunteers and donors, the organization provides community education and equine-assisted services. As a certified Maryland Horse Discovery Center, it offers equine-assisted learning programs where rehabilitated horses help youth and families build life skills through hands-on, ground-based activities.

- Sassafras Farms (sffarmsmd.com): A diversified farm that began operations in 1962, covering approximately 226 acres across two locations, and is owned by the Smart family. Chad and Curk Smart became a fully registered Black Angus cattle operation in 2010, with an emphasis on natural, high-quality beef through advanced breeding techniques. In 2015, the farm expanded by establishing its registered

Black Angus herd, and in 2021 it added registered Berkshire pigs, chosen for their marbling, tenderness and flavor. Sassafras Farms sells locally grown, hormone-and antibiotic-free beef and pork at its Dunkirk location.

- Swann Farms (swannfarms.com): A sixth-generation family farm established in the 1850s along the Patuxent River. Originally focused on tobacco and grain crops, the farm shifted in the 1990s to growing fruits and vegetables, including sweet corn, peaches, berries and tomatoes. Today, the farm operates a wholesale produce business serving local grocery stores, restaurants and roadside stands across Southern Maryland and features 20 acres of pick-your-own produce along with seasonal agritourism experiences like sunflower and pumpkin picking. Recognized for its conservation practices and community involvement, the Swann family was inducted into Maryland's Agriculture Hall of Fame in 2016.

Conklin admitted to consuming alcohol earlier in the evening and submitted to standardized field

sobriety testing. He was subsequently determined to be under the influence and placed under arrest. A search of the vehicle incident to arrest revealed 15 open Club Tails Cocktail bottles. Conklin was transported to the Calvert County Detention Center, where a secondary search of his person by correctional deputies uncovered a folded check containing multiple pills. Conklin was charged with CDS Possession – Not Cannabis, CDS Possession of Paraphernalia, Possession of CDS while Confined, CDS Opiate Without a Prescription, DUI, Negligent Driving, Reckless Driving, and several other traffic-related offenses.

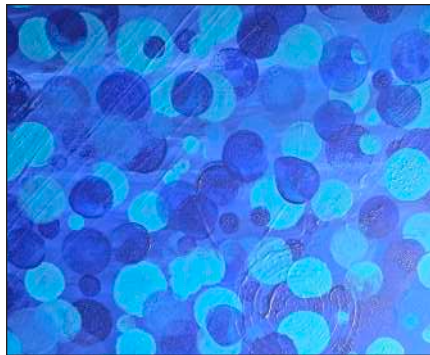

250 Years Later, Navy Has Deep Roots Within NAS Pax River, NAVAIR

October marks the 250th anniversary of the U.S. Navy—a milestone that honors centuries of courage, resilience and innovation. From the American Revolution through World War II to modern day conflicts in the Middle East, America's sea power has remained dominant to not only secure and support the country's allies and interests both near and far but also serve as a conflict deterrent. From the earliest ships that defended America's shores to today's cutting-edge aircraft and unmanned systems, the Navy's story is one of progress and dedication to protecting the nation's freedom.

Prior to the onset of the American Revolution, the original 13 colonies had no real naval force other than an abundance of merchant vessels that were engaged in domestic and foreign trade, according to Naval History and Heritage Command. The colonies' merchant service had vast experience with the open sea and with warfare, which included British naval expeditions against Cartagena, Spain and Nova Scotia during the nine years of war with France (1754–1763). Thus, the importance of naval power was recognized early in the conflict. The Department of the Navy was officially established on Oct. 13, 1775, by the Continental Congress, it also established

the U.S. Marine Corps on Nov. 10, 1775.

"From the ramparts of the Revolution, to the trenches of the Atlantic, to the islands of the Pacific and beaches of foreign shores, a global force for good was born, one that for 250 years would sail in the defense of our homeland, protect our national security interests and preserve our way of life," said Chief of Naval Operations Adm. Daryl Caudle during his remarks Oct. 12 at the Navy 250th Commemoration at its birthplace in Philadelphia. "So, tonight, let us remember that our Navy is more than the sum of ships, platforms and munitions: It is the product of our battle-hardened sailors

who are forged by the seas."

The first naval base was established in 1854 in Vallejo, California, and remained a source of shipbuilding, support and repair into the 1990s. The first naval air station was established in January 1914 in Pensacola, Florida, marking the addition of aircraft to the Navy's arsenal. Few bases embody the Navy's legacy more than Naval Air Station Patuxent River, Maryland, (NAS Pax River) and Naval Air Systems Command (NAVAIR).

Known as the "place where the future of naval aviation takes flight," NAS Pax River has been central to the Navy's mission for more than 80 years. Established in 1943

during World War II, the base became the Navy's premier test site for aircraft, weapon systems and aviation technology. Here, test pilots, engineers and sailors work together to ensure that every aircraft that takes to the skies is safe, effective and battle-ready.

Over the decades, NAS Pax River has been the proving ground for some of the Navy's most iconic aircraft—the F-4 Phantom, F-14 Tomcat and F/A-18 Hornet all underwent rigorous testing here. Today, NAS Pax River continues its role at the cutting edge, advancing next-generation platforms like the F-35 Lightning II, unmanned aircraft and systems that connect naval aviation into a seamless combat force.

"The Navy has always been at the forefront of innovation during its 250 years, and I'm proud to be at Pax as we celebrate this milestone, because of Pax River's place in that rich history of innovation," said Capt. Breast Cancer Walk Unites Community, Reduces Shame

The 3rd annual Ace's Angels Breast Cancer Awareness Walk and Pink Soiree will celebrate those in the community who have been affected by breast cancer during their event on Oct. 25 at the Leonardtown Wharf.

The event will feature guest speakers, vendors, live entertainment, and a kid's zone. Registration is required to participate, and every ticket comes with a t-shirt and bib.

Proceeds will fund Ace's Angels' mission to "provide financial support, education and emotional assistance to breast cancer patients and their families."

One hope of the walk is to reduce the shame individuals feel regarding illness. Lots of people in this community feel shame for their illness and are afraid to ask for help, founder Karen Thomas said. By bringing people together and giving them a space to share their stories, Ace's Angels hopes to make seeking support less intimidating.

Thomas was inspired to start the organization after losing her mother to breast cancer in 1997. Her mother, a social worker who often helped people in their neighborhood, died at age 50. Admiring her mother's charity, Thomas began to work with people in the community impacted by breast cancer—both those diagnosed and their loved ones.

Before creating Ace's Angels, Thomas participated in breast cancer walks from 2009 to 2016 with Susan G. Komen for the Cure, a national organization dedicated to finding a cure.

Wanting to expand her local impact, she started the nonprofit Ace's Angels. The organization connects with individuals through a referral process, either from the patients themselves or friends who reach out on their behalf. "A friend had asked me, what was my address? I thought she was coming by to see me... All of a sudden, I get a knock on the door. There was Ace's Angels. They were talking to me, and Karen's giving big old hugs, saying she's sorry, that Ace of Angels is there for me," said Anita Knighten, who

currently has stage two negative breast cancer. "She hands me an envelope. I'm thinking it's a card... there was a little bit of funds to help me get by. I was shocked."

Knighten said the organization made sure she was never alone. Thomas kept in contact with her through her journey, seeing if she needed a member of Ace's Angels to drive her to her next doctor's appointment, and checking in with her after it. "I'm so grateful for them, because without them, I don't know. They helped me out a lot. I was getting ready to be depressed, and then Karen talks to me and tells me everything's all right," Knighten said. "She sends little spiritual things about breast cancer... I just wish there was more out here than her to help a lot, because she's just one group."

Knighten has attended every Ace's Angels walk, but her treatments weakened her bones, and she recently had a knee replacement. When she worried she couldn't participate this year, Thomas offered to drive her in a buggy so she could still be part of the event.

Through fundraisers like the walk, Thomas hopes to expand how Ace's Angels helps the community. One of her goals is to find a way to reduce co-pay for those she assists. Thomas also wants to see more celebration and visibility for breast cancer awareness in everyday spaces. October is breast cancer awareness months, and Thomas said she's seen less and less people celebrating.

Additionally, she doesn't want breast cancer to be forgotten after October. Ace's Angels advocates for accessibility to mammograms and encourages women to get screened regularly. "If something doesn't feel right, get a mammogram," Thomas said. "People are afraid it hurts, I get them all the time, I just got one. They don't hurt."

One message Thomas hopes will reach the community is that Ace's Angels is open to anyone affected by breast cancer, regardless of background. As a Black woman, Thomas said she's aware some people mistakenly assume her group only serves Black women. "That's not the case," she said. "Cancer doesn't see race, cancer doesn't see color. We are here for everyone."

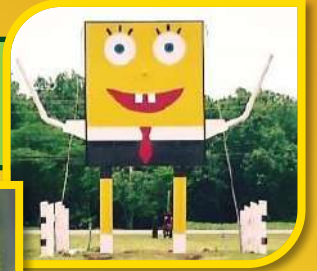

Firearm Recovered in Traffic Stop

Deputies from the Criminal Investigations Division of the St. Mary's County Sheriff's Office recovered a loaded unserialized firearm and arrested a suspect following a traffic stop on Friday, Oct. 17.

While conducting proactive enforcement in the 21000 block of Colton Point Road in Avenue, Detectives observed a subject known to be prohibited from possessing firearms due to his age, in possession of a suspected firearm.

Detectives requested members from the patrol unit to assist. Ultimately, a traffic stop was initiated on a gold sports utility vehicle on the 22000 block of Duke Street in Leonardtown. During the traffic stop, a search of the vehicle and occupants was initiated, and Omari Lee Miles, 18, of California, Maryland, a passenger in the vehicle, was found in possession of a loaded Polymer 80 9mm handgun with an extended 40-round magazine.

Miles was taken into custody and charged with multiple firearm-related offenses, including:

- Wearing a handgun on his person
- Wearing a loaded handgun on his person
- Wearing a handgun in a vehicle on public roads
- Wearing a loaded handgun in a vehicle

- Unlawfully possessing an unserialized firearm
- Possession of a regulated firearm while under the age of 21

Miles was transported to the St. Mary's County Detention and Rehabilitation Center and is currently being held without bond.

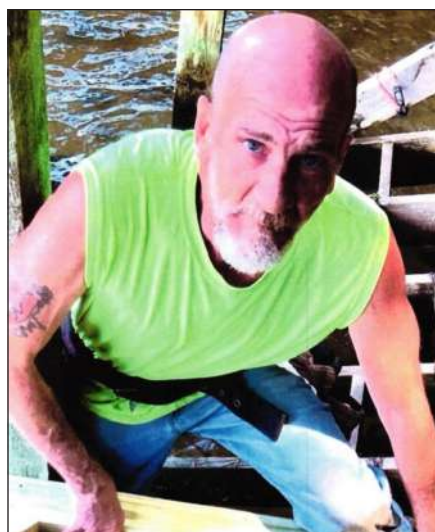

Help Sought on Anniversary of Disappearance

Southern Maryland Navy Alliance Safeguards County's Economic Engine

Leadership of the Southern Maryland Navy Alliance, which is a watchdog for the Navy's presence in St. Mary's County, briefed the Commissioners of St. Mary's County on Oct. 21 on their role and mission and activities on base.

Alliance President Dr. Dale Moore and Executive Vice President Jim Bolin made the presentation.

Moore said of their top priority, "We have a vehicle called the FAXX, which has completed source selection as far as I understand it, and ready for award. It's been held up at OSD (Office of Secretary of Defense) in particular. There's a lot of work going on on the Hill to try to make sure that that announcement comes out. That is our number one priority in the Navy Alliance to get that across the goal line, the tush push, so to speak."

He added, "It's highly political, but it's the future of Naval Aviation to take those technologies to the next level. And you're looking at collaborative combat aircraft to go along with that, which are unmanned. And you're seeing an unmanned spike going through the roof with autonomy and with our smart building and all that. It all fits in very nicely."

Moore talked about "the holistic nature of this region and how we are positioned to try to drive it forward so that community can thrive. That's the bottom line. The major economic driver is the base. NAWC-AD (Naval Air Warfare Center-Aircraft Division) add \$4.5 billion a year. NAVAIR (Naval Air Systems Command) headquarters is \$60 billion a year. The state doesn't realize that, and we've been trying to wave that flag and tell them, because we're kind of out of sight, out of mind right down here."

When they do outreach, Moore said, "We have a powerful argument. We have the best of all worlds. We've got quality of life, quality of professional activities, it just really couldn't be better. But we're trying to get that word out to attract the talent that we need, develop the talent that we need, working closely with the economic development community and everybody basically in that community."

Moore explained, "We've upgraded our mission statement a little bit. We're a non-profit organization, 501-C (4). So, we do hire a lobbyist to help us," adding, "we're trying to increase the awareness, foster collaborations and partnerships in the region, working closely across the academic institutions as well."

He explained, "We advocate for policy, programs, and fiscal resources. We have our eyes and ears out for those things that can impact Maryland positively and negatively. And so, it's really about our networks and

more importantly, the relationships that we develop over time with the representatives, their staffers inside the gate, their leadership, et cetera."

Moore noted, "The benefit of the Southern Maryland Navy Alliance is that we really do protect and promote St. Mary's County's number one economic engine. Jim and I both have decades of experience inside the gate, both military and civilian."

He said Sen. Chris Van Hollen secured \$3 million in funds for Southern Maryland 2030 Workforce Initiative "that was executed largely to the Patuxent Partnership."

He said over the last three years "We've had 181 450-hour apprenticeships that we've sponsored. We've had 128 college interns with eight professional development seminars each year. And over 2,000 what we call Spark Event high school participants across the three counties to make sure that our students at high school understand those professional opportunities that they

can migrate toward and keep them here."

The 100-member organization, he said, has a very strategic board. "We have two former admirals. We have three former senior executive service representatives that are three-star equivalent. And we have two former commanding officers of the base."

He explained, "We work as kind of the nexus of the ecosystem, so to speak, to make sure that there's consensus and synergy and coordination and partnerships and activities going forward."

Their current agenda, Moore said, includes "tracking the DOGE (Department of Government Efficiency) impacts, which is potentially significant." There're also tracking the impacts of the government shutdown (see separate story)

"We're on top of the Reconciliation Act," he said, "understanding that the National Defense Authorization Act, we had a fair amount of influence there. We have some people that are on the House Armed Services Committee. We work closely with our staffers. We build questions for them. We build narrative for them. We make sure they are informed."

"The big takeaway you may or may not have heard is in ship building, trying to get us backed up on game in ship building, but ships are expensive. So, we're trying to highlight the aviation side of the Navy as best we can."

The alliance president observed, "I would tell you that there are big muscle movements going on that may or may not have the due diligence to enable good decisions. So, we are really ear-to-the-tracks, basically on those kinds of issues to make sure that we're protected down here and taking advantage of any opportunities that go forward."

Public Hearing Set for Revised Transportation Plan

The Commissioners of St. Mary's County will hold a public hearing on Nov. 18 at 9:15 a.m. on the first update to the county's Transportation Plan in almost 20 years.

Acting Director of the Department of Public Works & Transportation Donald Mills told the commissioners on Oct. 21, "We started the project as an update in 2021, and we were still kind of in the restrictions with COVID and all. So, we gathered citizen input via online surveys, and we used the previous transportation plan, the 2006 plan, and we used input from our 311 citizen system. So, we took that data and we compiled it, and draft plan was created."

"We presented that plan to the Transportation Advisory Committee. They decided that they wanted to try to create a task force to focus on the information. The Transportation advisory Committee final-

ized their review in 2023. And they recommended that we present it to the Planning Commission for their review. So, we scheduled a meeting in September of 2024 at the planning commission. The planning commission made their review and asked that the critical lane volume level of service be added to the intersections that were listed in the plan. We made those revisions. That was very minor in nature, but we made those revisions and presented again to the planning commission with those minor changes in May of 25, and they recommended that we present it to you all."

Mills said the plan was available of Board Docs from the May planning commission meeting and a page would be created on the county website.

Commissioner Mike Alderson had a few observations. He said he reviewed the 2006 transportation plan. "I'm just bringing this up, so if people do decide to go look at this, you need to go look at page 30. About half-

way down, there's a line item to construct a second span of the Thomas Johnson Bridge. It was medium priority, and the price tag on that was \$131 million."

He observed, "We are close to a billion now I understand and what we've been told by United Bridge Partners when they came down."

Alderson noted, "The transit facility upgrade talks about putting shelters in the near future. I know since I've been on this board that's been Commissioner Hewitt's drum to beat to make sure we had for real shelters for folks. And I just want to get a good update on that for people, especially now that we're seeing increased ridership on the STS system."

Alderson also mentioned "an item I brought up with MDOT (Maryland Department of Transportation) when they came down for the traveling roadshow. I had spoken about a couple times about having a user activated red light at the trail crossing

on Route 5."

He added, "The ball's in their (the state's) court. But I would like to see if we can get a little more push behind that because I did receive a complaint Friday afternoon about a guy and a friend of his were trying to cross there and the lights were flashing yellow. People get desensitized to the yellow flash and lights. They entered a crosswalk. Traffic did not yield to them while they were in the crosswalk. The guy who was driving the car pulled over, jumped out of his car, and was going to have a little road rage incident with the pedestrians."

He said, "I've talked about having some kind of user activated red light where those lights go from flashing yellow to flashing red to wake people up a little, maybe we'll see. The traffic that I see going up and down the road to DC every day, it may or may not help, but just a couple things to put on the radar."

Commissioners React to Ongoing Government Shutdown

"We're on top of the shutdown to understand those impacts. And it's getting more severe every day," Southern Maryland Navy Alliance President Dr. Dale Moore told the Commissioners of St. Mary's County on Oct. 21 as the shutdown became the second longest in history.

After the alliance briefing, all five of the county commissioners took time to talk about it. And on the suggestion of Commissioner Eric Colvin, they will send a caustic letter to Maryland's two U.S. senators, Chris Van Hollen and Angela Alsobrooks, along with Senate Minority Leader Chuck Schumer.

Colvin said, "My understanding, it's now entering to be the second longest shutdown in US history. And we don't want to see it be the longest. And it's purely political. There's no good reason for this."

He added, "And there're impacts locally, and the impacts are going to increase locally. More and more people are furloughed. People who don't work on the base may not understand that there's different groups. And we had a good overview from the Navy Alliance today, but the NAWC (Naval Air Warfare Center) group on the base is Navy Working Capital. And that means their money is not appropriated from Congress, it's appropriated to other departments in the DOD and then sent to the NAWC. So, they don't really get furloughed right away, but when they run out of money, then they have to stop working. And the rumors out there are that the furlough is coming for a lot of NAWC employees. And that's not a good thing."

Colvin insisted, "There's just no good reason for this and it's really frustrating. So, I've had conversations with some of the other commissioners individually. I would propose that we send a letter to our senators, to Senator Van Hollen, to Senator Alsobrooks and Senator Schumer, so that he has awareness."

"I just know that as elected officials, we need people to push information up to us. And when we've had conversations with our partners at state and federal level, they always say push information up to them."

Colvin's motion included the following letter:

"Dear Senator,

"We're writing on behalf of the residents of St. Mary's County and the entire nation to ask that you break this stalemate, cross partisan lines and vote to approve a clean continuing resolution to fund the government and pay the hardworking Americans who are still doing critical work."

"Our proximity to Washington, DC and the presence of Patuxent River Naval Air

Station in St. Mary's County means that we have many residents who are furloughed or soon will be furloughed and are going without paychecks in spite of the fact that many are still doing vital national security work. The government shutdown has now reached the point of being the second longest shutdown in our nation's history and is being driven purely by politics. We are asking you to overcome the politics of the day and cross party lines and reopen our government."

"The impacts of the shutdown are far reaching and not fully known yet, but families are being impacted. We do not want to see the impacts on our residents worsen as elected officials. We know that sometimes hard choices must be made. We all choose to serve our citizens because we want to help make our communities better places to live, work, and raise a family."

"This choice is easy. Keep the government operating and ensure our people are being paid for the great work that they do."

The four commissioners in attendance agreed to sign the letter. Commissioner Mike Hewitt was not at the meeting, but Colvin said he would give him the opportunity to sign it.

Colvin added, "There's not much we can do from the local level. We can't offer loans like the state did, even though they're a small amount and you have to repay it relatively quickly. But we don't have the funds to do that. We have to keep county government operating. We can't employ people who are furloughed. We can advocate up the chain. Not that our voices are going to be heard any louder than anyone else's, but we can advocate. That is something that we can do. That's something we should do."

Commissioner President Randy Guy said, "I agree with you Commissioner Colvin one hundred percent. That was very good."

Guy added, "Reaching across the aisle, I keep hearing that all the time, but somebody's not reaching very well. And we need to move on with this because this is going to hurt us locally considerably."

Commissioner Scott Ostrow said, "I hope to see everybody out and around the county as always, especially during economic development week. Get out, support our local businesses. It's tough right now with the government shutdown and things going on. People are really being careful with the money that they're spending. But if it's possible, get out and support those local businesses who right now are really suffering because they're not getting that lunch traffic from the base and they're not getting any of what they need, especially our restaurants and a lot of our local stores. So, if you can get out, even if it's an inexpensive meal, get out there, support our local restaurants and businesses as much as we can because we

all have to help each other through this."

He added, "It's really a complete failure of our government that is a political football that they're just kicking around. There's absolutely no excuse for it. I know Commissioner Colvin has said many times they need to do their jobs and balance the budget and put forth a real budget we're required to every year. We can't get away with some continuing resolution or any of this. Our government should be required to do that as well. So, I'm very disappointed to see that our government is just really not doing their jobs, and they need to."

St. Mary's County's soup kitchen, St. Mary's Caring, is seeing the impact of the shutdown. Commissioner Mike Alderson said, "Last weekend I went to the St. Mary's Caring, fundraising brunch that they had down in Great Mills."

He said, "It's good to see so many people come out in support of St. Mary's Caring. It's great to hear of a couple of new partnerships they have. The Department of Social Services has moved their office into that building that is large enough to accommodate them. Their office that was on Great Mills Road is now at the soup kitchen location."

Alderson observed, "It makes it a lot easier for the folks in the county who need those services to be able to come to one location and receive the services they need and the guidance that they need to help them get themselves back on track."

He added, "I was very excited to be there when Dr. Mimi Novello from MedStar announced a new partnership with St. Mary's Caring, where they're going to have a small office there, where they're going to hold classes, things like one burner cooking, health classes, trying to get people on track with the primary care physicians to help them control any kind of conditions they have, be it heart disease, diabetes, or something like that, to get them on a path to wellness that is easily manageable and provide partnership and guidance for them."

Alderson said he suggested financial literacy classes, especially in these tough times.

He said, "The 10 percent you get off at your purchases at Target for applying for their credit card really sort of doesn't pan out 90 days later when you're paying 39.9 percent on that same credit card. That's where a lot of people get in trouble."

Alderson relayed, "Going along with financial literacy, the 1.4-trillion-pound gorilla in the room that affects a huge portion of Maryland and especially Southern Maryland, is this federal government shutdown. I am one of the exempted employees, so I get to pay for my privilege of driving to DC four days a week so I can work for free for now. Eventually I'll get paid but eventually doesn't pay my bills. Now, thankfully,

several years ago I decided that I was going to go ahead and make myself as financially literate as possible. And I did the whole emergency fund and everything. I strongly suggest everybody try to get up a three-to-six-month emergency fund. It takes a while and you have to sacrifice, give up going out to dinner a couple times a month if you have to put that money aside and put it in high yield savings account, and it's there when you definitely need it."

He added, "Something that has been coming from the government shutdown shows... the woeful absence of civics, how government actually operates. Yes, the Republicans have the majority in the House and in the Senate, and then at the White House. But in order to pass the CR (continuing resolution) they need 60 votes. There are 53 votes out there for the Republicans. So, when everybody gets on Facebook or has their arguments about the Republican shutdown, Schumer shutdown, there's enough blame to go around to everybody. But people need to know civics and how things operate between the three branches and how many votes are needed for a CR to get this through."

He noted, "Our senators from the state of Maryland who represent some of the largest population of federal workers in the nation, should go ahead and look for what's best for their constituents and not what's best for their party. Because at the end of the day, they answer to the people and not to the DNC. The same goes for the Republicans too."

He added, "If you want to cut government, save spending, that's fantastic. Do not do it where government employees are being held hostage to temper tantrums and grandstanding. That's going on in the well of the Senate now."

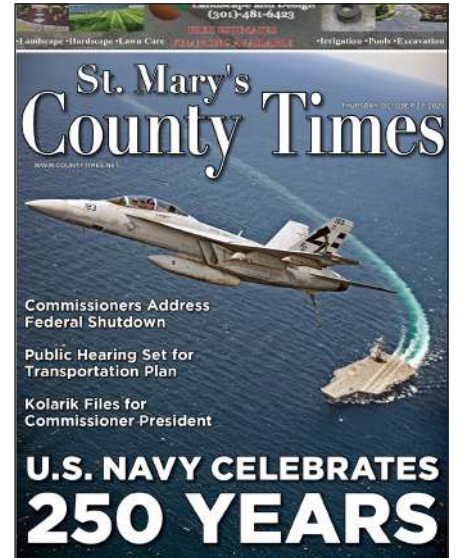

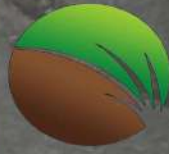
